REGIONS BANK, an Alabama banking corporation and successor by merger to AmSouth Bank, having its principal office in Birmingham, Alabama and a mailing address of 417 North 20th Street, Birmingham, Alabama 35203 ("Seller"), hereby irrevocably constitutes and appoints the individuals listed on **Exhibit A** hereto, each a resident of North Carolina and each having a mailing address of c/o Poyner & Spruill LLP, 3600 Glenwood Avenue, Raleigh, North Carolina 27612 (each, individually, an "Attorney in Fact" and collectively the "Attorneys in Fact"), its true and lawful attorneys in fact and agents, with full power of substitution, for it and in its stead, to execute, endorse and act upon as necessary, any mortgage assignments as necessary to effect the assignment and recordation of the loans and mortgages assigned from Seller to RBC Centura Bank, a North Carolina banking corporation ("Purchaser") pursuant to that certain Purchase and Assumption Agreement (the "Agreement"), dated as of November 1, 2006, between Seller and Purchaser.

No person who may have dealings with any Attorney in Fact shall be under any duty to notice, or to inquire into, the actual power or authority to do anything which the aforesaid attorney may undertake to do in an effort to exercise any power herein conferred. The powers herein conferred shall remain in full force and effect until notice to the contrary comes to the actual attention of the person or entity with whom aforesaid attorney may deal. Any person dealing hereunder with any Attorney in Fact respecting any matter hereunder may rely conclusively, and shall be fully protected in relying upon any certificate or representation made by such Attorney in Fact at the time of such dealing, and stating that this power of attorney is then in full force and effect. This power of attorney shall not be affected by any liquidation or dissolution of the undersigned.

Notwithstanding the foregoing, the appointment herein made and the power to act hereunder shall be limited so that any actions taken hereunder must be consistent with the terms of the Agreement, and the power granted hereunder shall be limited by the terms of the Agreement. This power of attorney is coupled with an interest.
