**VERIFIED CLAIM OF LIEN**

Select Granite, Inc., a corporation qualified under the laws of the State of Alabama, by and through Michael C. Flanagan, as President, who has personal knowledge of the facts herein set forth, files this statement in writing, verified by his oath. Select Granite, Inc. claims a lien upon certain real property situated in Shelby County, Alabama, more particularly described as follows, to-wit:

**Lots 22-93 and 22-94, according to the Survey of Highland Lakes, 22<sup>nd</sup> Sector, Phase II, an Eddleman Community, as recorded in Map Book 36, Page 94 A-C, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.**

This lien is claimed, separately and severally, as to the land, building and improvements thereon to the extent of the entire lot or parcel which is contained within a city or town. If said land is not within a city or town, this lien is claimed, separately and severally, as to the buildings and improvements located on the above-described real property, plus one (1) acre of land surrounding and contiguous thereto.


