
## VERIFIED CLAIM OF LIEN

Issis & Sons Carpet, Inc. ("Issis"), a Corporation organized under the laws of the State of Alabama, by and through Brock G. Murphy, Esq., its Attorney-In-Fact who has personal knowledge of the facts herein set forth, files this statement in writing, verified by his oath. Issis claims a lien upon certain real property known as Lot 38, Crest at Greystone, Shelby County, Alabama, which includes (on information and belief only) property more particularly described as follows, to-wit:

This lien is claimed, separately and severally, as to the land, buildings and improvements thereon to the extent of the entire lot or parcel which is contained within a city or town. If said land is not within a city or town, this lien is claimed, separately and severally, as to the buildings and improvements located on the above-described real property, plus one (1) acre of land surrounding and contiguous thereto.

This lien is claimed on the above-mentioned land, buildings and improvements to secure the indebtedness owed by Hendrickson Construction, LLC in the amount of Eleven Thousand Eight Hundred Fifty-Six and 20/100 Dollars (\$11,856.20), plus accrued interest, late fees and collection costs (including, without limitation, attorney's fees, court costs and case-related expenses), said sum being due and owing after all credits have been given, from the 1st day of



August, 2007, and which sum, plus accrued interest, late fees, attorney's fees and costs thereon, is presently due and unpaid.


