CATHODIC PROTECTION EASEMENT

KNOW ALL MEN BY THESE PRESENTS that for and in consideration of the sum of
-Ten- Dollars (\$10.00) paid
to the undersigned (hereinafter called "Grantor", whether one or more, the receipt and
sufficiency of which is hereby acknowledged, the said Grantor does hereby grant and convey
unto SOUTHERN NATURAL GAS COMPANY (hereinafter called "Grantee"), its successors
and assigns, the right of way and easement to construct, maintain and operate telephone lines,
electric transmission and power lines, and all necessary or desirable appliances and
appurtenances thereto, including poles, rectifiers, together with the right to install and bury under
the surface of the ground below plow depth, pipes, cables, ground pipes or beds at or near the
location of said poles, and wires connecting said electric transmission line with said pipes,
cables, ground pipes or beds and with any pipelines of Grantee, all to be located on the following
lands, over, across in and upon the following described lands situated in Shelby
County, State of Alabama, to-wit:

PROPERTY DESCRIPTION

A strip of land containing 0.413 acres lying in the SE¼ of the SE¼ of Section 17, Township 20
South, Range 3 West, Shelby County, Alabama and being 15 feet right and 15 feet left of the
following described line, which is depicted on SNG Drawing Number CU-206, To Wit:

To locate the point of beginning commence at a 3 inch capped pipe found marking the southeast
corner of said Section 17; thence N88°41'42"W on the south boundary of said Section a
distance of 1177.50 feet to a point; thence N48°43'31"E a distance of 196.97 feet to the point of
beginning; thence continue N48°43'31"E a distance of 600.00 feet to the point of ending, said
point lying on the southwest boundary of an existing Southern Natural Gas Company Right-of-
Way.

The right of way and easement hereby granted is more particularly depicted and
delineated on Southern Natural Gas Company Drawing No. CU-206, marked Exhibit
"A" attached hereto and made a part hereof.

Together with the right of ingress to and egress from said strip of land across adjacent lands of the Grantor and all the rights and privileges necessary or convenient for the full enjoyment and use of said right-of-way and easement for the purpose above designated.

It is hereby understood that the parties securing this grant in behalf of Grantee are without authority to make any covenant or agreement not herein expressed.

TO HAVE AND TO HOLD the said right-of-way and easement perpetually unto the said SOUTHERN NATURAL GAS COMPANY, its successors, assigns and lessees, provided, however, that the Grantor herein expressly reserves for itself and its successors and assigns the right to use and enjoy the premises above described in so far as such use and enjoyment by the Grantor, its successors and assigns shall not unreasonably interfere with the use of said easement and right-of-way by the said Southern Natural Gas Company, its successors, assigns and lessees under the grant herein set forth, and provided further that the Grantor and its successors and assigns will place no permanent structures upon the said right-of-way and easements. The Grantor expressly covenants that it is the owner in fee of the real property herein conveyed and has a good right to execute this agreement and to grant said easement and right-of-way.

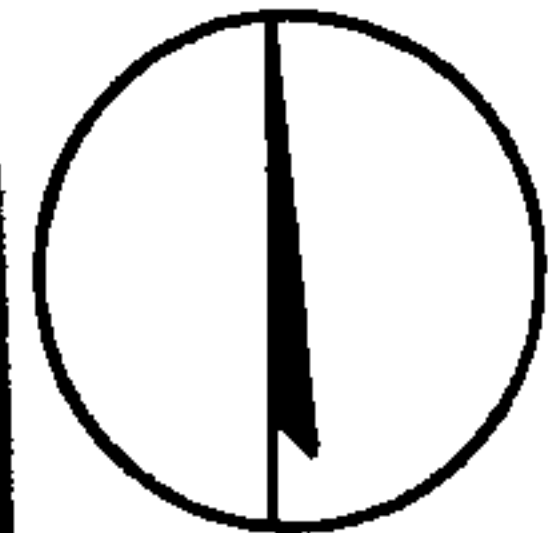

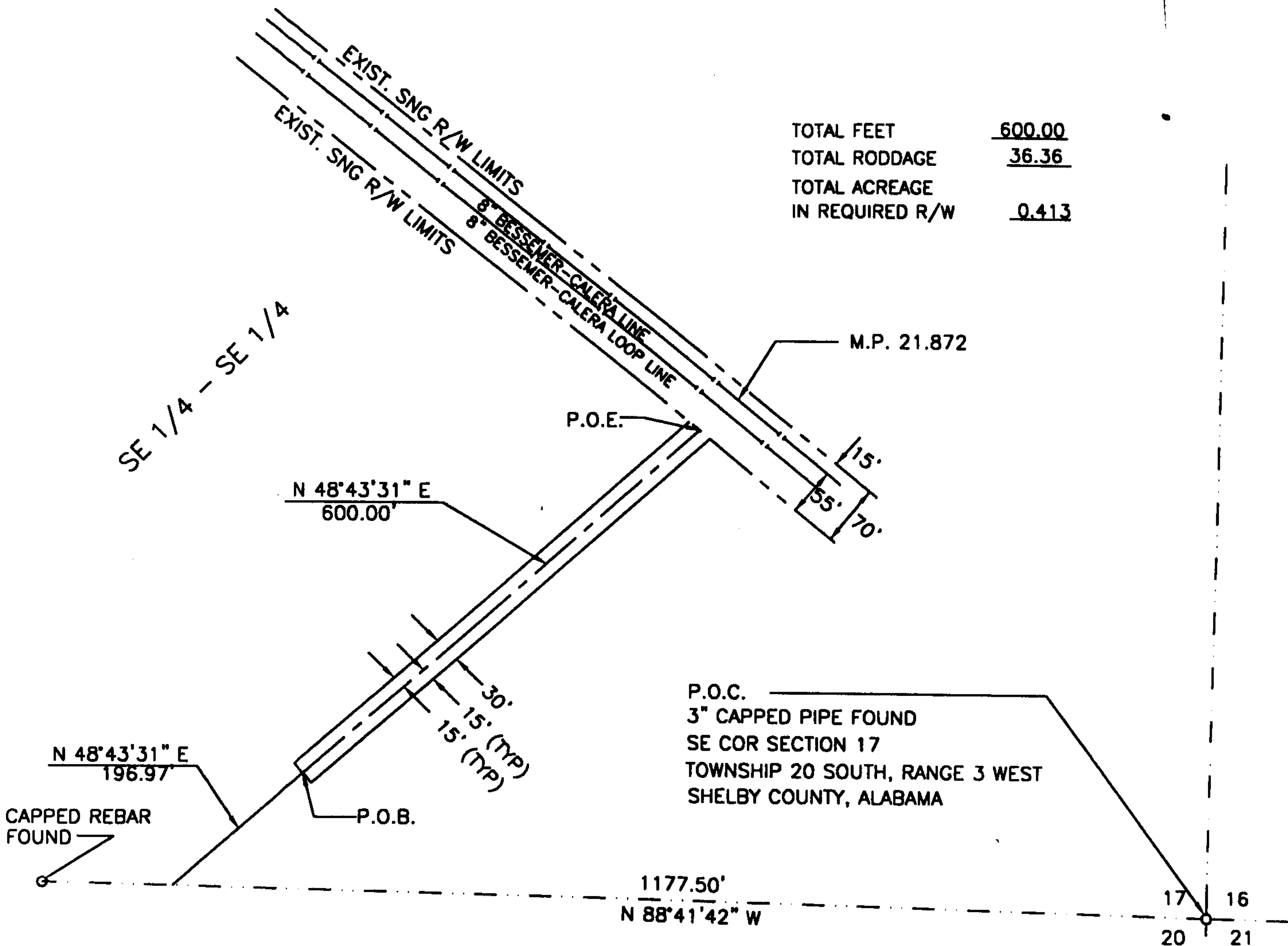
