KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of July, 2005, Jeremy B. Rahill and Angela C. Rahill, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument # 20050801000385160, said mortgage having subsequently been transferred and assigned to Everhome Mortgage Company, and


