- 2. A. The original settlor(s) and successor settlor(s), if any, of the trust was:


 Harold A. Rubin

 The conditions for the succession of the successor trustee(s) are: If any on or more of these death Trustees is unwilling or unable to serve as a Trustee, or if a Trustee cannot continue to serve for any other reason, then Houston Speed shall be named a successor death Trustee.
