THAT IN CONSIDERATION OF thirty-four thousand nine hundred and 00/100 Dollars (\$34,900.) paid to the undersigned Grantor, in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **WFS Holdings, LLC**, an Alabama limited liability company (herein referred to as Grantor), does grant, bargain, sell and convey unto **HAVEN HOMES, LLC**, an Alabama limited liability company (herein referred to as Grantee), the following described real estate (herein referred to as the Property), situated in the State of Alabama, County of Shelby, to-wit:

LOT 23 according to the Final Plat of Cross Creek Subdivision, as recorded in Map Book 38, Page 3, in the Probate Office of Shelby County, Alabama.

THIS INSTRUMENT IS EXECUTED AS REQUIRED BY THE ARTICLES OF ORGANIZATION AND OPERATIONAL AGREEMENT OF WFS HOLDINGS, LLC AND SAME HAVE NOT BEEN MODIFIED OR AMENDED.

ALL OF THE ABOVE PROCEEDS WERE PAID PURSUANT TO MORTGAGE LOANS CLOSED SIMULTANEOUSLY HERewith.

The above Property is conveyed subject to:

2. Matters such as, but not limited to, easements building setback lines, right of ways, and limitations as to use as shown on the Record Map of Cross Creek Subdivision, as recorded in Map Book 38, Page 3, in the Office of the Judge of Probate of Shelby County, Alabama;
3. Ail valid and enforceable easements, covenants, conditions and restrictions of record, including, without limitation, that certain Declaration of Protective Covenants as recorded in Instrument # 20070118000027360 in the Probate Office of Shelby County, Alabama;
4. Title to all minerals within and underlying the premises, together with all mining rights and other

rights, privileges, and immunities relating thereto, together with any release of liability for injury or damage to persons or property as a result of the exercise of such rights;

For purposes of this paragraph, the term Grantor shall mean and refer to (i) the members, agents and employees of Grantor; and (ii) any successors and assigns of Grantor. This covenant and agreement shall run with the land conveyed hereby as against Grantee, and all persons, firms, trusts, partnerships, limited partnerships, corporations, or other entities holding under or through the Grantee.

TO HAVE AND TO HOLD unto the said Grantee, its successors and assigns, forever.

Grantor makes no warranty or covenant respecting the nature of the quality of the title to the property hereby conveyed other than that the Grantor has neither permitted nor suffered any lien, encumbrance or adverse claim to the property described herein since the date of acquisition thereof by the Grantor.

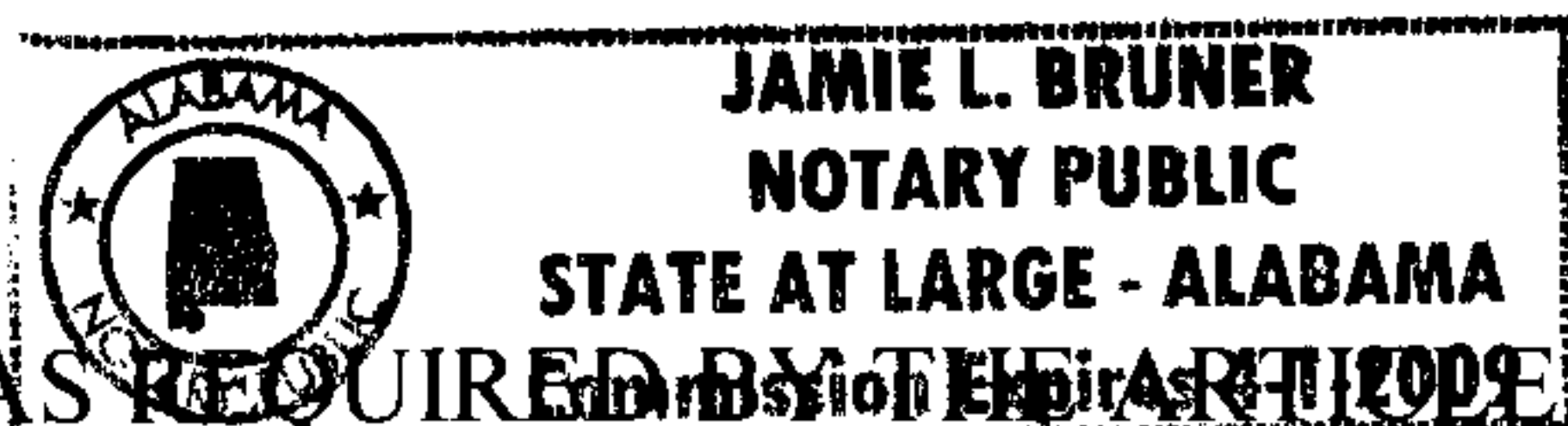

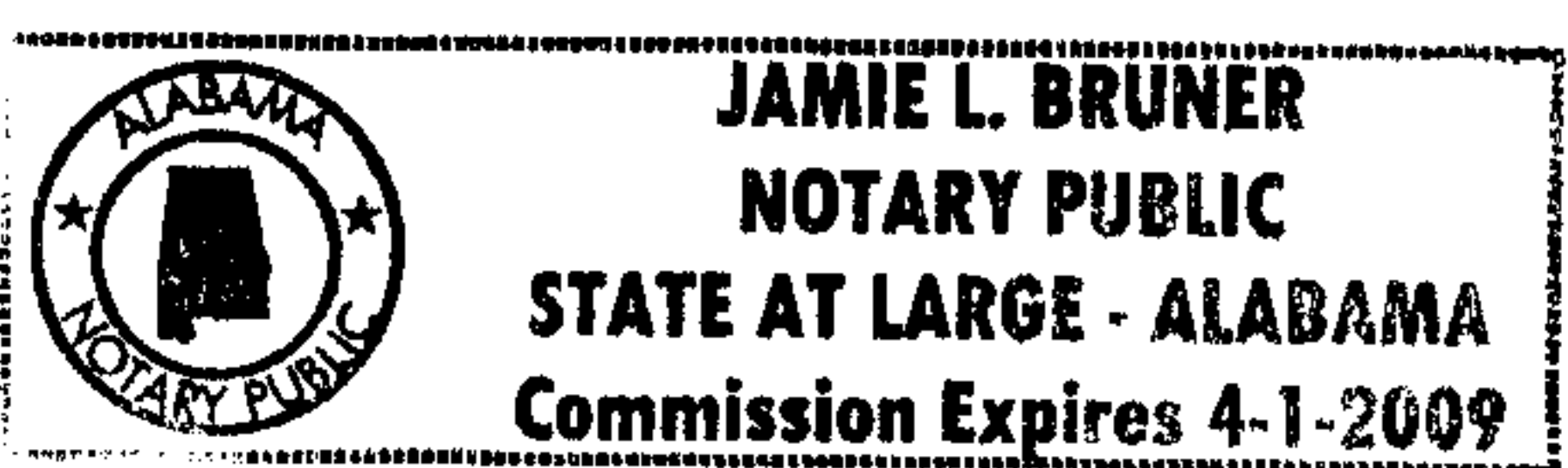
