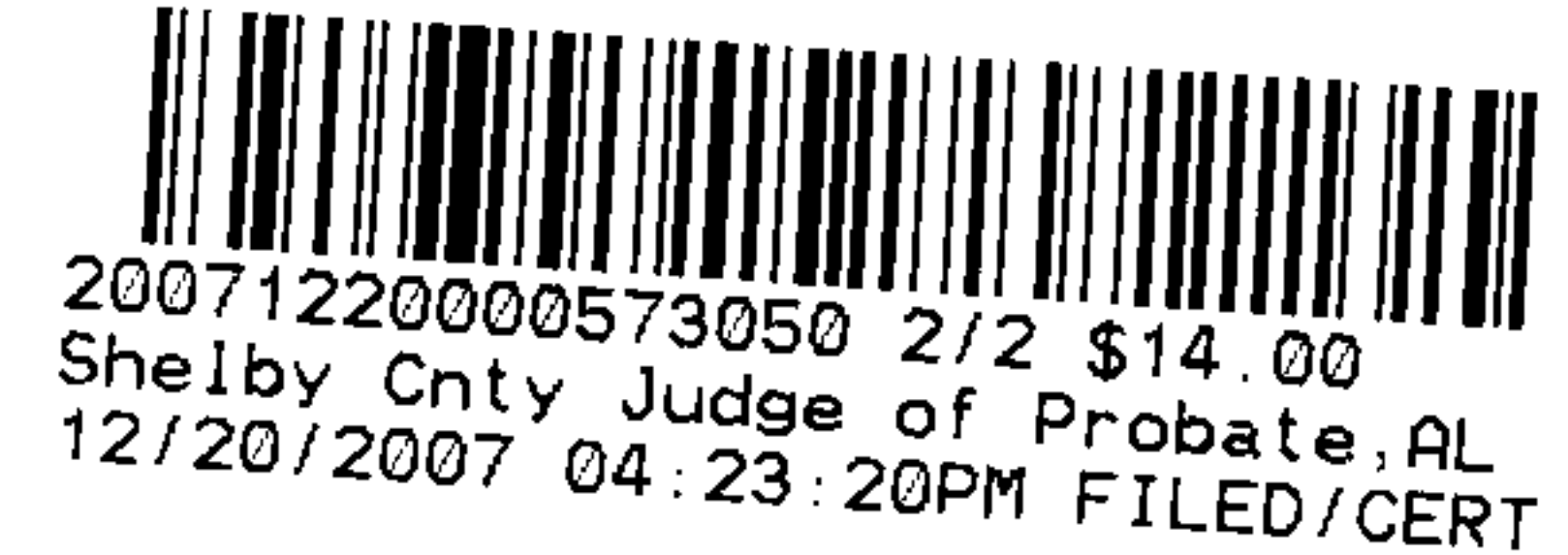
That Jenkins Brick Company claims a lien upon the following property situated in Shelby County, Alabama, to-wit:
