SCRIVENER'S AFFIDAVIT

Before me the undersigned Notary Public, in said state, in said county, personally appeared Denise Clements, who after being duly sworn does say as follows:

My name is Denise Clements and am employed by Bryant Bank. One of my duties as an employee of Bryant Bank is the preparation of mortgage and on March 3, 2007, I prepared a mortgage wherein Building Resources, Inc was the borrower and Bryant Bank was the lender and that mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama in Instrument 20070316000119410.

This mortgage contained an incorrect legal description which read as follows:

The mortgagor did have any ownership interest in Lot 69 and should not have been included on the original preparation of the above described mortgage.

The legal description that should have been typed as follows:

Lot 17B, according to a Resurvey of Lot 17, The View at Indian Crest, as recorded in Map Book 38, Page 52, in the Probate Office of Shelby County, Alabama.

This correction as to the legal description should be incorporated into that mortgage referenced above.
