Articles of Organization Guidelines

Instructions:

Step 1: The name of the Limited Liability Company must contain the words Limited Liability Company, LLC or L.L.C.

Step 2: File the original and two copies of the Articles of Organization in the county where the LLC's registered office is located. The Judge of Probate's filing fee is \$35.00 and the Secretary of State's filing fee is \$40.00.

Pursuant to the provisions of the Alabama Limited Liability Company Act, the undersigned hereby adopts the following Articles of Organization.

*Article I* The name of the Limited Liability Company: Gregory Clark Agency, LLC

*Article II* The duration of the Limited Liability Company is: 50 years

*Article III* The Limited Liability Company has been organized for the following purpose(s):  
To provide insurance needs to businesses and individuals and any extension thereof,  
Or related products and/or services




