FIRST AMENDMENT TO ASSIGNMENT OF RENTS AND LEASES

THIS FIRST AMENDMENT TO ASSIGNMENT OF RENTS AND LEASES (this "First Amendment") is made and entered into as of December 20, 2007, by and between SMCMOB, L.L.C., an Alabama limited liability company (the "Borrower"), and REGIONS BANK, an Alabama banking corporation (the "Lender"). Capitalized terms used herein but not defined shall have the meanings ascribed to such terms in the Loan Agreement (as hereinafter defined).


WHEREAS, Wachovia Bank, National Association (successor by merger to SouthTrust Bank, the successor by conversion to SouthTrust Bank, National Association, the successor by conversion to SouthTrust Bank of Alabama, National Association) ("Wachovia") previously made available to Borrower certain credit facilities pursuant to the terms of that certain Construction Loan Agreement dated as of March 23, 1994, between Borrower and Wachovia, which Construction Loan Agreement has been assigned by Wachovia to Lender pursuant to that certain Assignment, Acceptance, Agreement and Release of even date herewith (the "Assignment of Loan Documents") among Borrower, Lender and Wachovia (as so assigned to Lender, and as heretofore and hereafter amended from time to time, the "Loan Agreement"); and

WHEREAS, Borrower previously executed and delivered in favor of Wachovia that certain Assignment of Rents and Leases, dated March 23, 1994, which instrument was recorded in the office of the Judge of Probate of Shelby County, Alabama, as Instrument No. 1994-11313, and which instrument has been assigned to Lender pursuant to the Assignment of Loan Documents and pursuant to that certain Assignment of Leasehold Mortgage and Security Agreement and Assignment of Rents and Leases of even date herewith executed by Wachovia in favor of Lender and recorded in the office of the Judge of Probate of Shelby County, Alabama as Instrument No.

(as so assigned to Lender, and as amended from time to time, the "Assignment of Rents"); and

WHEREAS, Borrower and Lender desire to amend the Assignment of Rents as provided for hereinafter.

- NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Borrower and Lender hereby agree that the Assignment of Rents is amended as follows:
- 1. The Assignment of Rents is hereby amended to provide that (A) any reference therein to the "Construction Loan Agreement" shall mean the Loan Agreement as defined in this First Amendment; (B) any reference therein to the indebtedness or obligations secured thereby shall include the Swap Obligations (as defined in the Loan Agreement); (C) any reference therein




to the "Loan" shall mean and include the Loan as defined in the Loan Agreement; and (D) any reference therein to the "Note" shall mean and include the Note as defined in the Loan Agreement.

- 2. Except as hereinafter expressly amended, the terms of the Assignment of Rents are hereby ratified and affirmed.
- 3. In the event of any conflict between the provisions of the Assignment of Rents, as hereby amended, and the provisions of the Loan Agreement, the provisions most favorable to Lender shall control.
