REVOCATION OF GUARDIANSHIP

KNOW ALL PERSONS BY THESE PRESENTS that I, **JOSEPH ALAN WOODS**, being the legal and natural father of **NATHANIEL ALAN WOODS** (hereinafter referred to as the "Child"), with the Child's date of birth being October 23, 2005, and I, **MARY ELIZABETH WOODS**, being the legal and natural mother of the Child, both of SHELBY County, Alabama (jointly referred to as the "Parents"), do say as follows:

On the 4th day of October, 2006, the Parents executed their Appointment of Co-Guardians, naming the following individuals as Co-Guardians of the Child: the Child's maternal grandparents, **WILLIAM PERRY MORGAN and DEBBIE MORGAN** and the Child's paternal grandparents, **JOSEPH CARDWELL and JOAN CARDWELL** (collectively referred to as the "Guardians"), with said Appointment of Co-Guardians being formally recorded in the Office of the Judge of Probate of Shelby County, Alabama, on the 4th day of October, 2006, as Instrument #20061004000491020.

Said appointment was made under the provisions of §26-2A-71(a) of the Code of Alabama (1975), as amended, which provides as follows:

"§26-2A-71. Parental appointment of guardian for minor. (a) The parent of an unmarried minor may appoint a guardian for the minor by will, or other writing signed by the parent and attested by at least two witnesses or acknowledged."

Said Guardianship was granted due to circumstances under which the best interests of the Child necessitated such Guardianship.

Due to a change in circumstance, said Guardianship is no longer required for the benefit of the Child and said Child is back in the care of his natural mother.

The Parents therefore revoke the Appointment of Co-Guardians heretofore executed by them on the 4th day of October, 2006, and the guardianship heretofore granted to: the Child's maternal grandparents, **WILLIAM PERRY MORGAN and DEBBIE MORGAN** and the Child's paternal grandparents, **JOSEPH CARDWELL and JOAN CARDWELL** is therefore terminated as of the date of the Parents' execution of this Revocation.

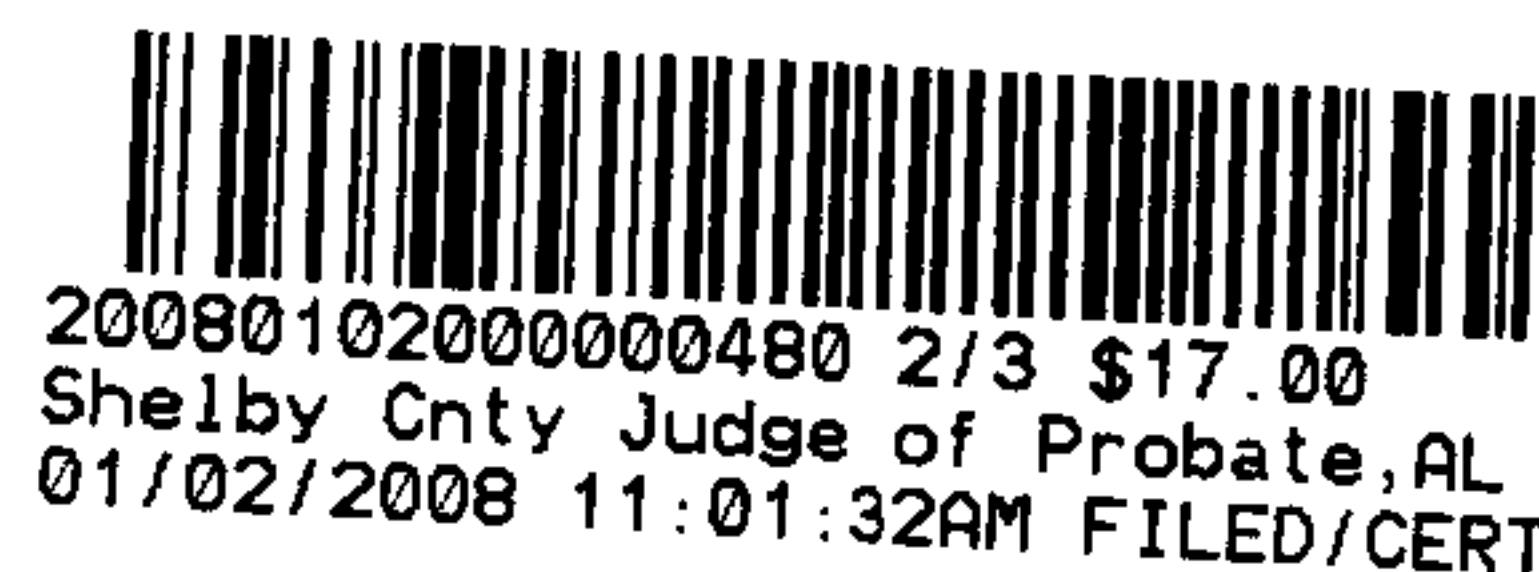
