Description of Property

The following described parcel of land located in Shelby County, Alabama:

A parcel of land lying in the SE 1/4 of the NE 1/4 and the NE 1/4 of the SE 1/4 of Fractional Section 20, Township 22 South, Range 2 West, and more particularly described as follows: Starting at the Southeast corner of said Fractional Section 20, Township 22 South, Range 2 West, run Northerly a distance of 705.3 feet to the centerline of the Southern Railroad; thence turn an angle of 69 degrees 09 minutes to the right and run Northeasterly 325.32 feet to the center of the intersection of said Southern Railroad with 18th Street; thence turn an angle of 66 degrees 08 minutes to the left and run Northerly 1390.5 feet to the West side of the pavement of said 18th Street; thence turn an interior angle of 89 degrees 00 minutes to the right and run Westerly to, and then along a 6-foot high chain link fence of the ABEX Corp., a distance of 660.2 feet to a corner of said fence; thence turn an interior angle of 89 degrees 52 minutes to the right and run Southerly along said fence a distance of 228.02 feet to the point of beginning; thence continue along said fence a distance of 349.1 feet to a corner in said fence; thence turn an angle of 90 degrees 00 minutes to the right and run Westerly a distance of 450.3 feet to a corner in said fence; thence turn an interior angle of 88 degrees 36 minutes to the left and run Northerly a distance of 318.1 feet to an iron marker; thence turn an interior angle of 95 degrees 25 minutes to the left and run Easterly a distance of 443.6 feet to the point of beginning.
