**Subject to The Covenants and By-Laws of Countrywide Estates.**


**Subject to easements, exceptions, reservations, encumbrances, liens, rights of way and restrictions of record or visible on said property.**

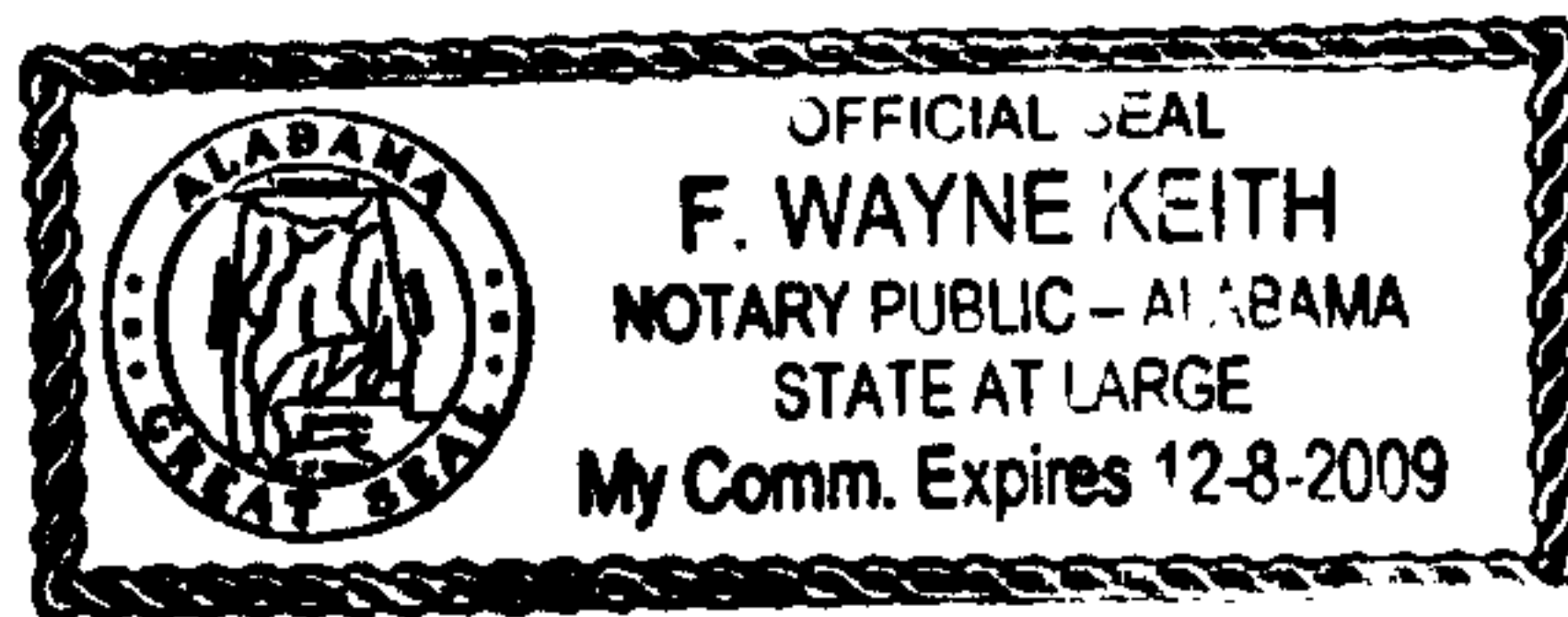


