

LAST WILL AND TESTAMENT

I, Lucy E. Anderson, a resident of Shelby County, Alabama, being over the age of twenty-one (21) years, do hereby make, publish, and declare this instrument as and for my Last Will and Testament, hereby expressly revoking any and all wills and codicils heretofore made by me. On the date of the execution of this Will, I am not married. I have four children, Valerie Anderson, Alvin Anderson, Avon Anderson, and Aaron Anderson. I have not made provisions for Alvin Anderson, Avon Anderson, or Aaron Anderson for reasons they will understand.

ITEM ONE

I direct that all of my just debts be paid by my Executrix hereinafter named, as soon after my death as is convenient.

ITEM TWO

All the rest, residue, and remainder of my property of whatsoever kind and character and wheresoever situated, real, personal and mixed, I give, bequeath, and devise unto my daughter, Valerie Anderson, absolutely, in fee.

ITEM THREE

Should my daughter, Valerie Anderson, not survive me for a period of five (5) days, then, in that event, all the rest, residue, and remainder of my property of whatsoever kind and character and wheresoever situated, real, personal, and mixed, I give, bequeath and devise unto Robert Scott Parker, absolutely in fee.

ITEM FOUR

I hereby nominate, constitute, and appoint Valerie Anderson as Executrix of this my Last Will and Testament. To the extent that such requirements can be legally waived, I direct that my

Executrix shall not be required to give bond or file an inventory, accounting or final settlement of my estate in any court. During the administration of my estate, I hereby vest in my Executrix full power to sell, convey, exchange, lease for a period beyond the termination of the administration of my estate, or for a less period, improve, borrow on the security of, encumber, or otherwise dispose of, all or any part of my estate, in such manner and upon such terms and conditions as my Executrix may approve, and to invest and reinvest my estate and the proceeds of sale of any portion thereof in such loans, stocks, bonds, or other securities, mortgages, participation in mortgages, or other property the Executrix may consider suitable and to change investments, and make new investments from time to time as to the Executrix may seem necessary or desirable. To the extent that such requirements can be legally waived, my Executrix shall be free from supervision of the probate court, or any other court in the exercise of the foregoing provision.

Should Valerie Anderson not survive me for a period of five (5) days, or should Valerie Anderson refuse to serve as Executrix or be unable to serve as Executrix for any reason, then, in that event, I hereby nominate, constitute, and appoint Robert Scott Parker as Executor of my estate and I hereby grant to the Executor all of the powers herein above granted to Valerie Anderson as Executrix.
