KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS, heretofore on, to-wit: May 10, 2006, J. Elliott Corporation, mortgagor, executed a certain mortgage to Compass Bank which said mortgage is recorded in Instrument # 20060522000240390, in the Office of the Judge of Probate of Shelby County, Alabama; and,
