Regarding Wyatt Vaughn-Trader's temporary relocation to Alabama—

According to the affidavit that Justin Trader sent to me to sign, I am required to give a reason as to why I am relinquishing temporary guardianship.

(The document asks for the "emergency reasons" that have compelled this decision. There is NO emergency reason. My son simply wants to complete this school year at his father's residence.)

I am the custodial parent in a joint custody situation. Wyatt's father, Justin Trader and I have privately agreed to allow Wyatt this "trial period" in Alabama without going through the courts and amending our divorce decree. (From 1-20-08 until 6-1-08.)

I have attached a copy of this agreement.


I will agree to relinquish "temporary" custody/guardianship only to Justin Trader as this is the only way my son can enroll in school in Alabama, according to school policy as referred to me by Donna Dickson.

I DO NOT relinquish guardianship to anyone other than Mr. Trader.

I still expect to retain the same rights that Mr. Trader always has, as the non-custodial parent, during this time. I will expect to be notified of any and all major decisions regarding Wyatt and his well-being.

Should an emergency situation arise and Wyatt is returned to my custody before June 1, 2008, I expect that my full legal rights as guardian/custodial parent to be restored immediately. If Justin Trader should be deployed or becomes otherwise unavailable to Wyatt at any time, I expect to have my full legal rights as guardian/custodial parent immediately restored.
