SUBORDINATION AGREEMENT

WHEREAS, David E. Wojczynski and Jennifer M. Wojczynski (hereinafter referred to as "Borrower"), has applied to **Liberty** Mortgage Corporation (hereinafter referred to as "Bank") for a loan of money in the amount of \$301,300 to be secured by a mortgage on the property hereinafter described; and

WHEREAS, the undersigned have a lien on said property which would in the absence of this agreement be superior to the mortgage to be executed by the Borrower to the Bank; and

Together with the non-exclusive easement to use the private roadways, Common Areas and Hugh Daniel Drive, all as more particularly described in the Greystone Residential Declaration of Covenants, Conditions and Restrictions dated November 6, 1990 and recorded in Real 317, page 260 in the Probate Office of Shelby County, Alabama.
