That for and in consideration the sum of Two Thousand Five Hundred Five and 36/100ths (\$2,505.36) and other good and valuable consideration, in hand paid to the undersigned, the receipt of which is hereby acknowledged, the undersigned, North Shelby County Fire & Emergency Medical District, by and through its President, Dodd Adair President of the board of Trustees of the North Shelby County Fire & Emergency Medical District, a public corporation organized under the laws of the State of Alabama, Grantor(s) herein, whether one or more, hereby grants, bargins, sells, conveys and redeems unto Antoinette M. Bonilla, as Grantee(s), whether one or more.

North Shelby County Fire & Emergency Medical District foreclosed its lien on this property, pursuant to Act 62 of the 1977 First Special Term of the Alabama Legislature, as amended, for failure of the current owner(s), Antoinette M. Bonilla or the legal owner whose duty it was to pay said special assessment on said property, as it became due and payable. The property was thereafter foreclosed by the North Shelby County Fire & Emergency Medical District on November 13<sup>th</sup> 2000 and purchased by the said North Shelby County Fire & Emergency Medical District and recorded in *Instrument Number*: 2000-42702 in the Probate Court of Shelby County, Alabama on December 12<sup>th</sup> 2000.

This redemption deed hereby cancels the following foreclosure deed which is recorded in Instrument Number: 2000-42702. The 2008 fire dues have been paid. This in no way limits North Shelby County Fire & Emergency Medical District's ability to foreclose its liens on this property in future years due to the owner's failure to pay any future fire dues as they become due.
