

- (B) To have custody, possession and or control of all of my property, real, personal or mixed and to collect income therefore; and to sell, alienate, convey, encumber, mortgage or otherwise dispose of any of my property, real, personal or mixed wherever situated and to execute any deed, mortgage, release, waiver, and/or any other instrument necessary or proper in connection therewith.
- (C) To execute releases of notes and mortgages payable to me or in which I have any right, title or interest, in whole or in part, and to authorize other persons to do so by instrument in writing. $\mathcal{M}, \mathcal{R}, \mathcal{D}$.

- (D) To improve, repair, lease, or rent for improvement, or otherwise, and to let, exchange ,release, partition, vacate, dedicate and adjust the boundaries of any real estate in which I have any right, title or interest; and/or to represent me and my interest in any condemnation proceeding relating thereto.

- (F) To make contracts and incur legal obligations on my behalf and to pay and discharge any such legal obligation incurred and generally to make contracts and incur legal obligations in my behalf in the same manner as I could do in my own right.


