



Harvest Boundary Identification

The boundary lines are identified on Exhibit "B-1." All boundary Boundary Lines: lines are marked on the ground with blue paint, except where harvest is directly on a property line, where it is red paint. The Buyer shall perform all of its logging operations within said boundary lines. Trees within any riparian leave tree area and leave tree retention areas (as identified on Exhibit "B-1") shall not be cut. Buyer shall fall timber in such manner that it shall lie within the boundaries of the Contract Area and no tops or other debris shall extend outside the boundaries of the Contract Area and Buyer shall be solely responsible for any loss or damage including but not limited to plantation damage caused by yarding/decking, suffered by Selier or other owners in the event of the violation of the provisions of this paragraph.


