KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **Two Hundred Sixty Five Thousand dollars and Zero cents (\$265,000.00)** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Dianne C. Calamas, a single woman** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Anthony Kyle Greene and Cathy E. Greene as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:

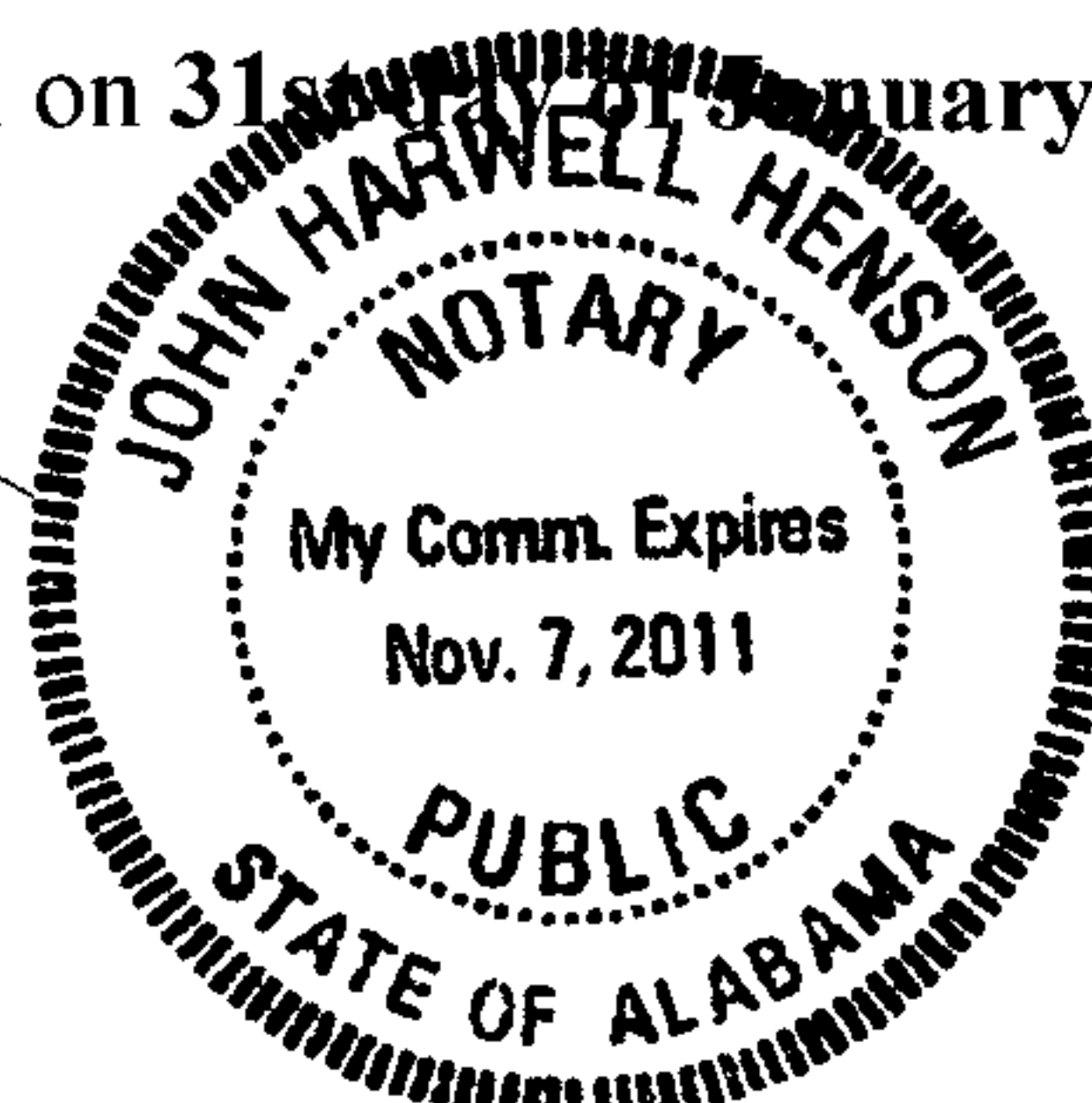
