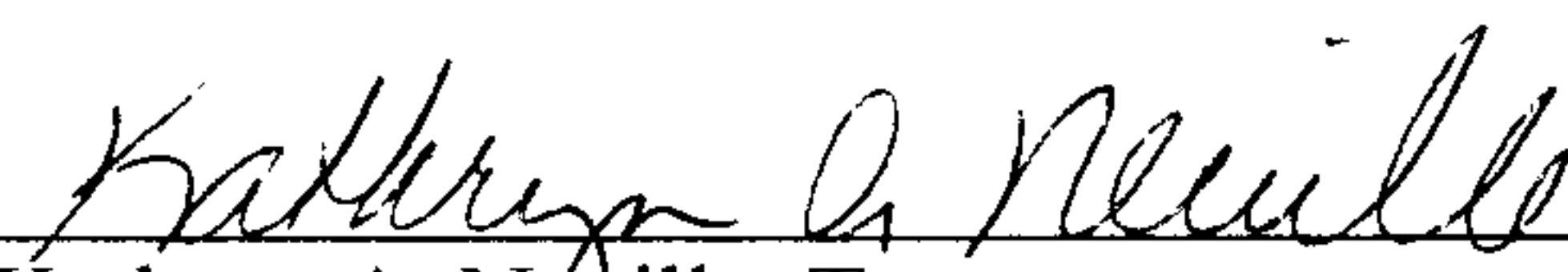
The undersigned Trustor and Trustee hereby certify the following:

All persons relying on this document regarding my Trustee and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. 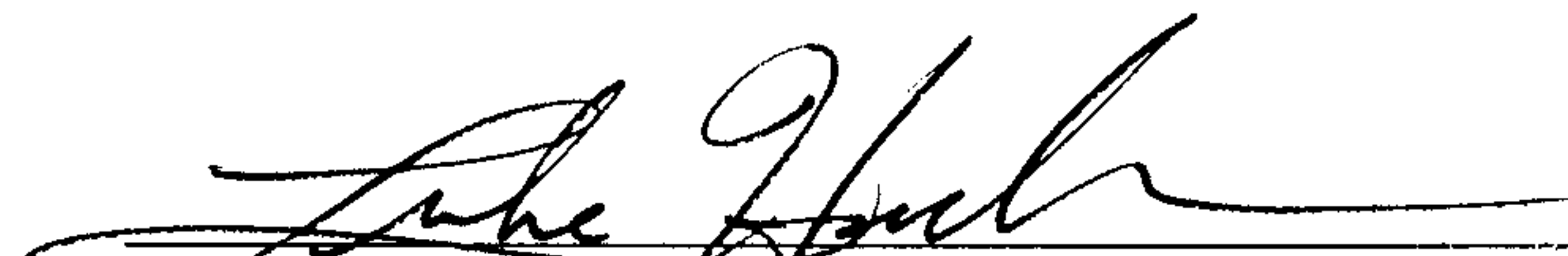
