KNOW ALL MEN BY THESE PRESENTS,

That in consideration of **ONE HUNDRED FIFTY THOUSAND AND 00/100 (\$150,000.00) DOLLARS** to the undersigned Grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Mark Lewis Mullis, as Personal Representative of the ESTATE OF CHARLES CLAYTON HARBOUR, deceased** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **JANICE SEAMAN** (herein referred to as Grantee, whether one or more), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:


