KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of May, 2003, Roger N. Turner and Kim C. 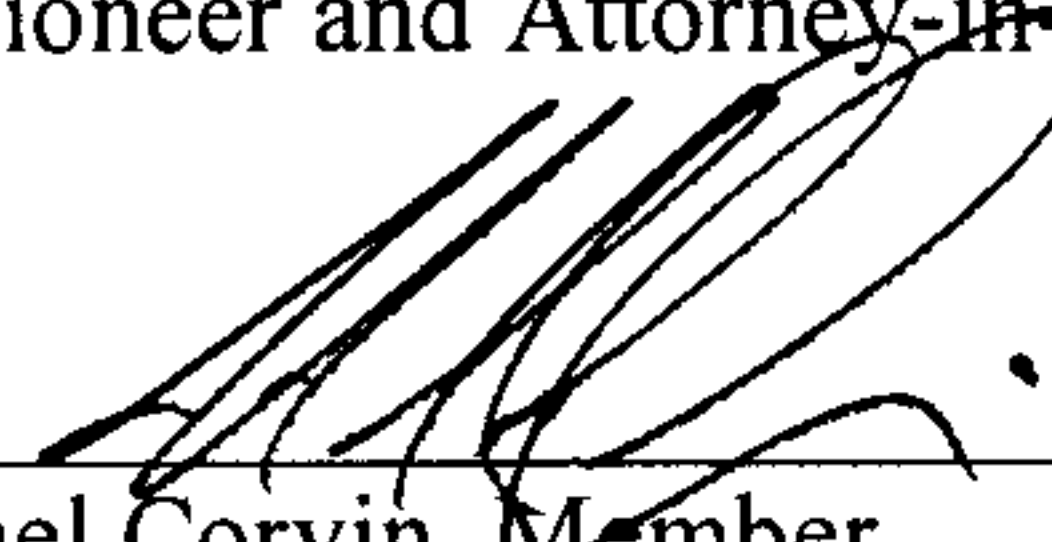

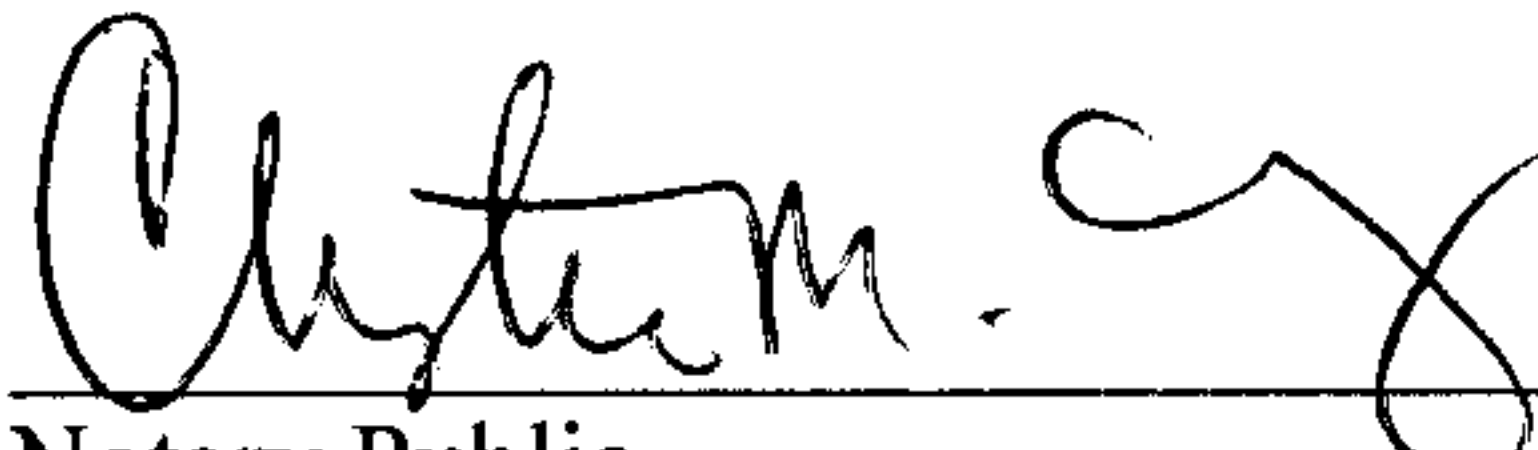
