KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of March, 1998, Philip J. Carpri and wife, Tammy R. Carpri, husband and wife, executed that certain mortgage on real property hereinafter described to Johnson & Associates Mortgage Co., Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument # 1998-11679; having been re-recorded in Instrument No. 1998-13660, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N. 
