

**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
DOULOS MINISTRIES**

Pursuant to the provisions of Section 10-3A-81 *et seq.* of the Code of Alabama (1975), as amended, the undersigned nonprofit corporation hereby adopts the following Articles of Amendment to the Articles of Incorporation of Doulos Ministries

**FIRST:** The name of the nonprofit corporation is Doulos Ministries. Upon the filing of these Articles of Amendment, the name of the nonprofit corporation will be Doulos Partners.

**SECOND:** The following amendment to the Articles of Incorporation of Doulos Ministries was adopted by unanimous written consent of the Board of Directors on the 7<sup>th</sup> day of February, 2008, in the manner prescribed by the Alabama Nonprofit Corporation Act:

"Article First is hereby deleted in its entirety, and the following is substituted in lieu thereof:

**FIRST:** The name of the nonprofit corporation is Doulos Partners (the "Nonprofit Corporation"). The period of duration for the Nonprofit Corporation is perpetual.

Wherever else in said Articles the name 'Doulos Ministries' shall appear, the same shall be deleted and the name 'Doulos Partners' shall be substituted in lieu thereof."

**THIRD:** The nonprofit corporation has no members.

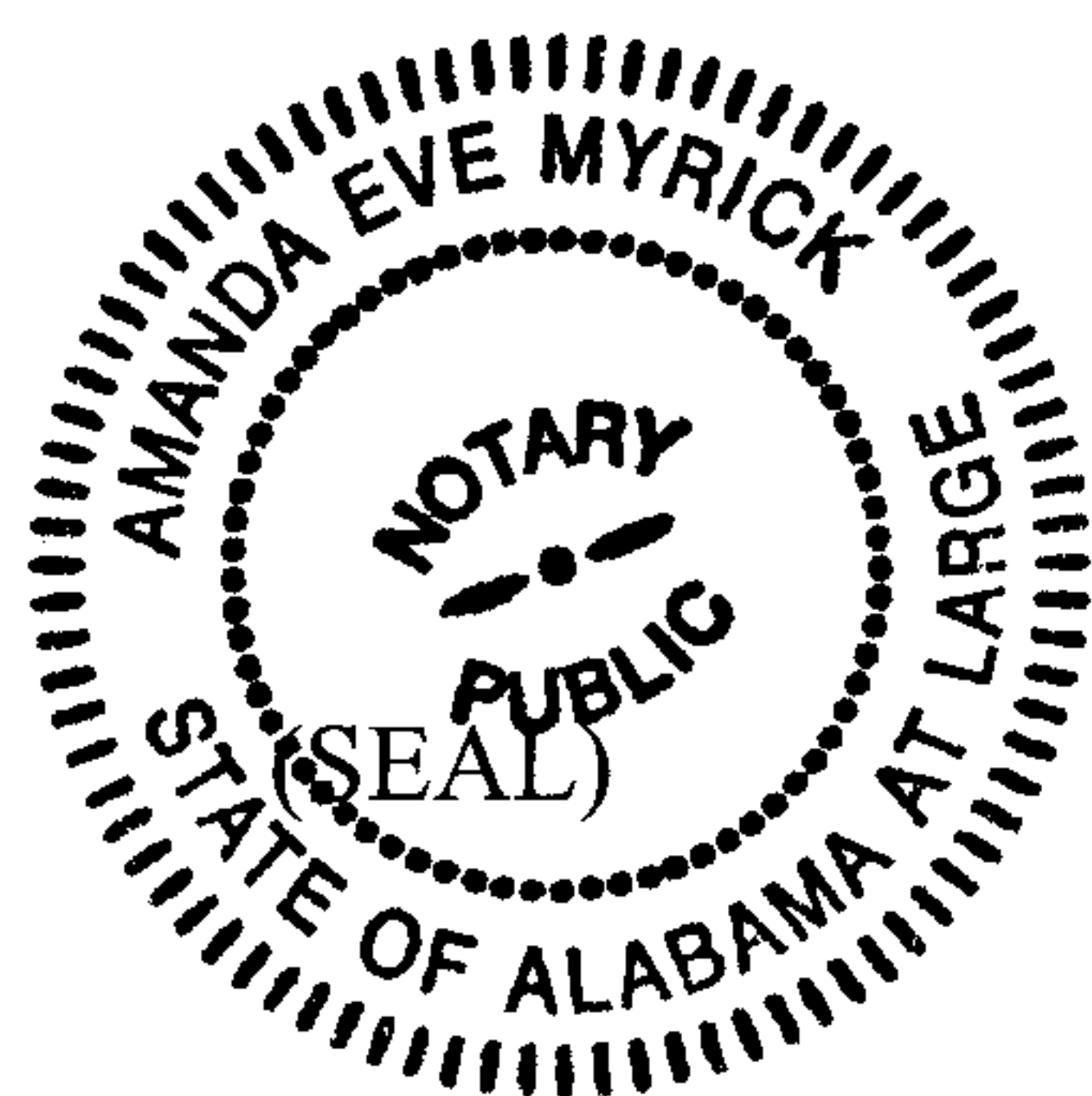
