The undersigned represents Joshco, Inc., d/b/a Butler Contractors ("Joshco") in the above matter. Joshco, Inc. requests the Clerk to file and record an Amendment to its previously filed legal description attached as Exhibit "A" to its Statement of Verified Claim of Lien filed in Shelby County Probate Court on December 21, 2007. As grounds therefore, Joshco states as follows:

1. 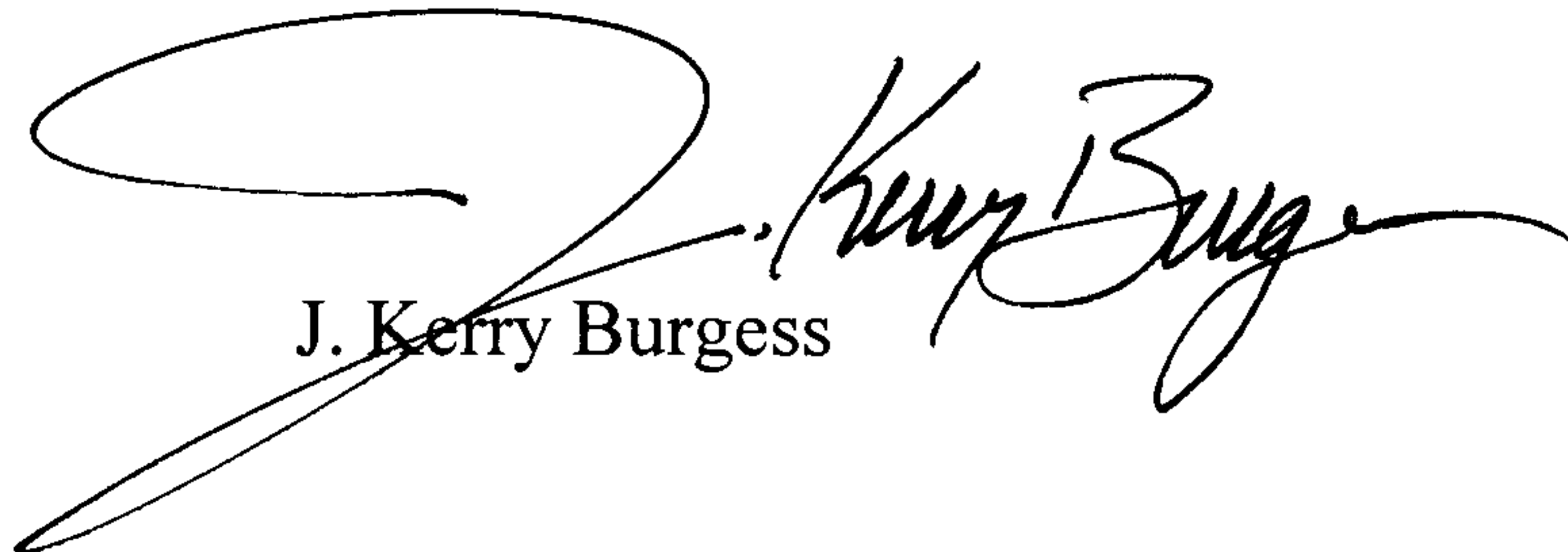

That said JOSHCO, INC., d/b/a Butler Contractors, claims a lien upon certain real property owned by Spratlin Construction, Inc., situated in Shelby County, Alabama, upon information and belief, the legal description is more particularly described in the attached **Exhibit A**.

This lien is claimed, separately and severally, as to both the buildings and improvements thereon, to the extent of the entire lot or parcel which is contained within a city or town. 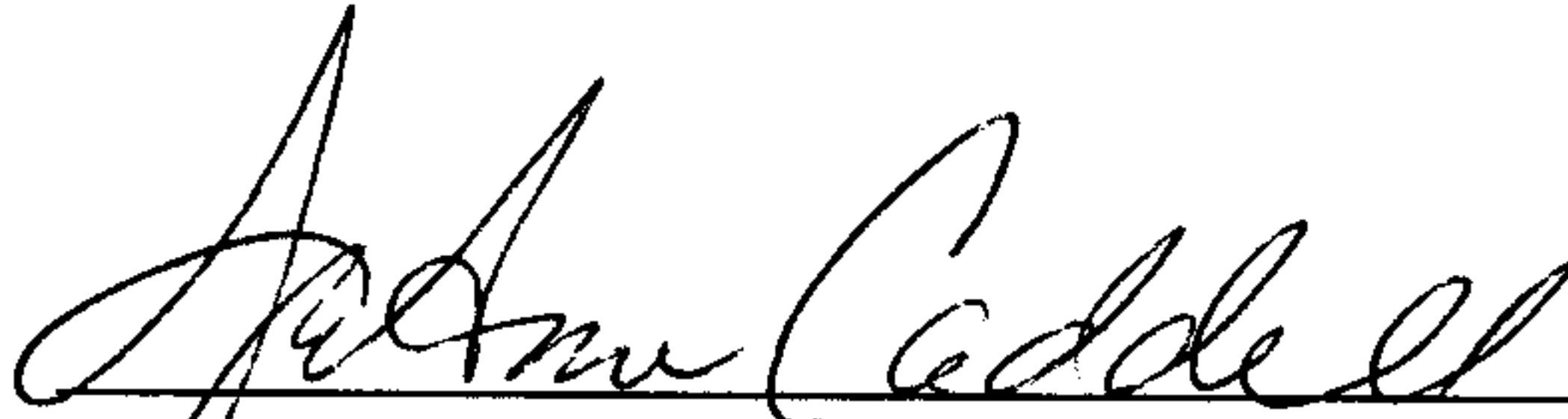
