WHEREAS, Shelby 52 Partners, LLC conveyed certain real property (the "Property") to The Trustees of the Presbytery of Sheppards and Lapsley by that certain deed (the "Deed") recorded as Instrument #1999-12466 in the Probate Office of Shelby County, Alabama; and

WHEREAS, a sanitary sewer easement (the "Easement") was reserved in the Deed to serve the Benefitted Parcel, as identified in the Deed; and




