

The original Mortgage, Deed of Trust, or Security Deed referenced above secures a home equity revolving line of credit. The \$47,500.00 principal amount of the line of credit secured by the original Mortgage, Deed of Trust or Security Deed is changed to \$68,000.00 and this change in the principal amount is evidenced by a Credit Agreement executed by some or all of the Grantors and dated the same date as this Modification. 
