ORDER GRANTING PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT

This matter coming before the Court based on the Motion for Summary Judgment filed by Main Venture as Plaintiff and Counter-Defendant and by Al Ray Moore as Third-Party Defendant.

After receiving evidentiary submissions of the parties, written arguments of the parties and hearing oral arguments by the respective counsel, the Court finds that there is no genuine issue as to a material fact and:


1. That the Plaintiff is entitled to a Judgment on the issues raised by the Complaint and the Counter-claim as a matter of law; and
2. That the Third-party Defendant, Al Ray Moore, is entitled to a Judgment as to all pending issues as a matter of law.

It is, therefore, ORDERED, ADJUDGED and DECREED, by the Court that the Motion for Summary Judgment is granted in favor of the Plaintiff and the Third-party Defendant as to

all claims pending in the above styled civil action;

1. That Judgment is hereby entered in favor of the Plaintiff, Main Venture, LLC and against the Defendant, Zohra Mohamed in the amount of \$134,212.24 consisting of a principal balance on the Note dated October 29, 1999 of \$82,760.24 plus interest of \$23,856.00 plus an attorney fee of \$27,587.00 and costs;
2. A Judgment is hereby entered in favor of the Plaintiff, Main Venture, LLC and against the Defendant, Zohra Mohamed for the personal property listed in Exhibits "A1", "A2" and "A3" attached to this Judgment which has an alternate value of \$5,000.00;
3. A Judgment is hereby rendered in favor of the Plaintiff, Main Venture, LLC and against the Defendant as to all claims raised by the Counter-complaint;
4. A Judgment is hereby rendered in favor of the Third-party Defendant, Al Ray Moore and against the Defendant/Third-party Plaintiff as to all claims pending in the above-styled action.
5. This ruling disposes of all claims pending in the above-styled civil action and is a final judgment in accordance with Rule 54 of the Alabama Rules of Civil Procedure.
6. That a copy of this Order be forwarded to counsel of record for all parties.
