This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and as to the said land.



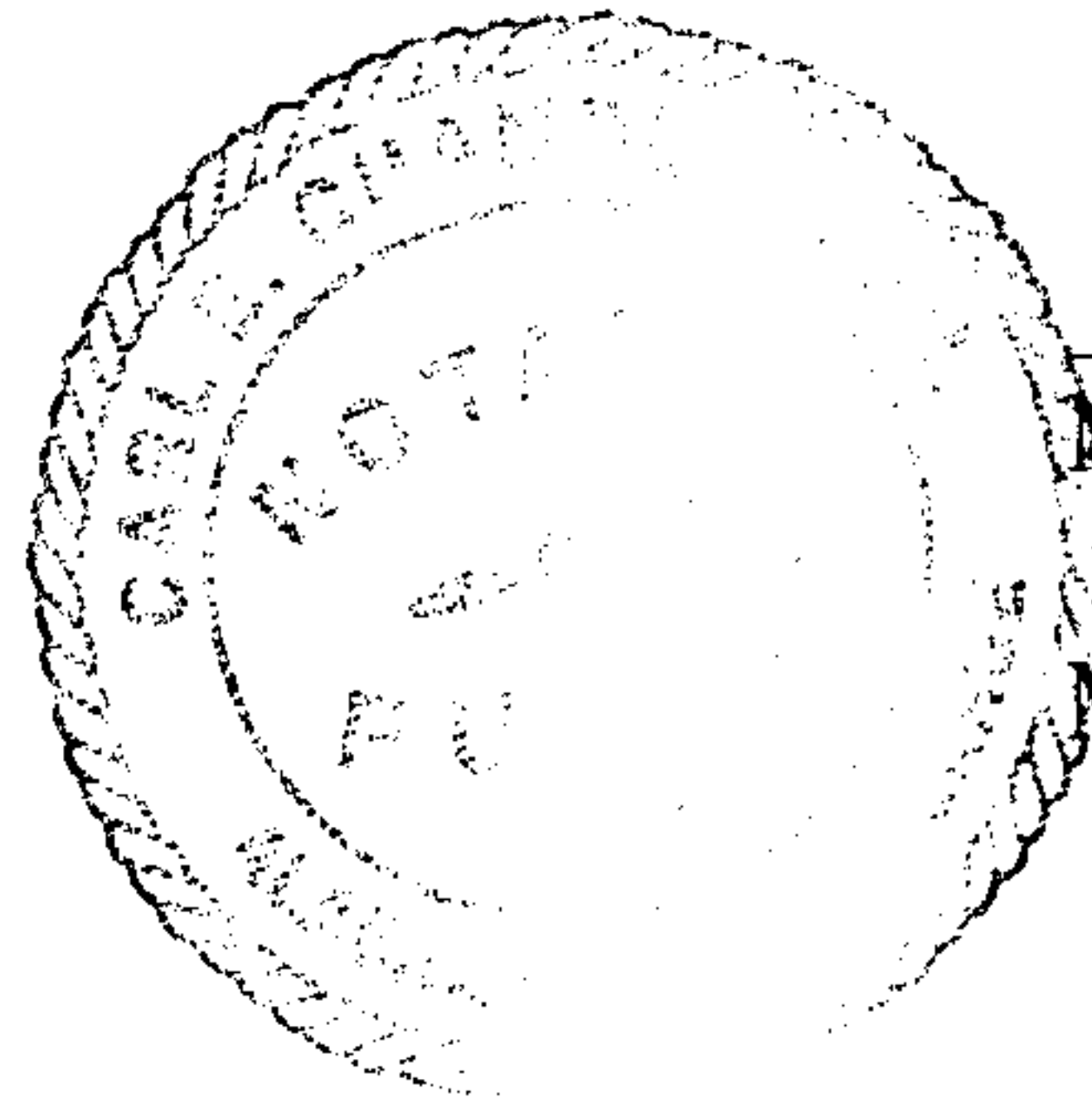
