1. That the said **DUNCAN CUSTOM GUTTER, INC.**, an Alabama Corporation claims a lien upon the following property situated in SHELBY County, Alabama, to-wit:

LOT 30-19, ACCORDING TO THE SURVEY OF HIGHLAND LAKES 30TH SECTOR, AN EDDLEMAN COMMUNITY, AS RECORDED IN MAP BOOK 34, PAGE 116, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

Together with nonexclusive easement to use the private roadways, Common Area all as more particularly described in the Declaration of Easements and Master Protective Covenants for Highland Lakes, a Residential Subdivision, recorded as Instrument 1994-07111 and amended in Instrument 1996-17543, and further amended in Instrument 1999-31095, in the Probate Office of Shelby County, Alabama, and the Declaration of Covenants, Conditions and Restrictions for Highland Lakes, a Residential Subdivision, 30th Sector, recorded in Instrument 20050531000260070 recorded in the Probate Office of Shelby County, Alabama (which, together with all amendments thereto, is hereinafter collectively referred to as the "Declaration")

This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and as to the said land.

2. That the said lien is claimed to secure an indebtedness of **\$ 6,376.45**, which includes interest from OCTOBER 1, 2007 (which is the date final payment was due on the indebtedness and the last date any materials were provided to real estate). Said indebtedness incurs additional interest of \$1.02 per diem, after the date of this lien.

3. That the said indebtedness is for the cost of labor and materials provided to real estate.

4. That the name of the owner or proprietor of said property is NEW HAVEN HOMES, LLC. BANCORPSOUTH BANK is the holder of a mortgage on said property.

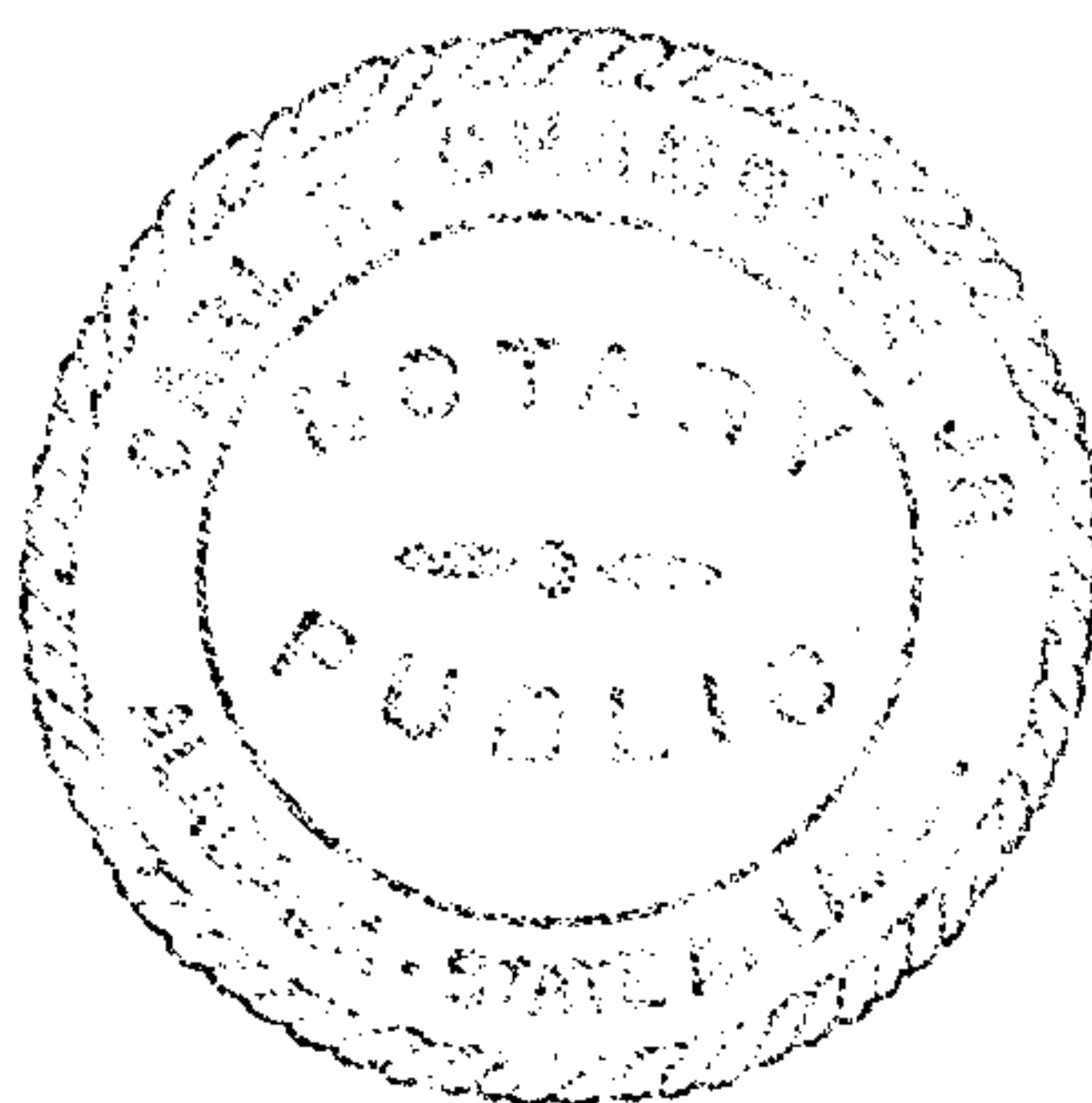
