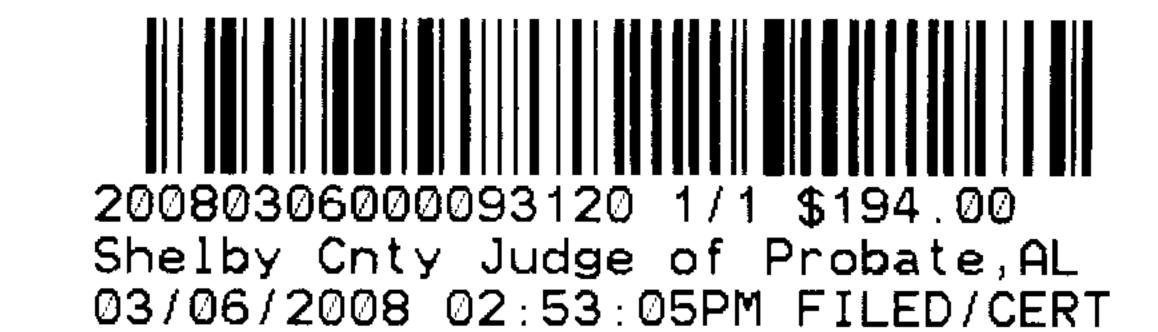

## **MORTGAGE**
