FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of November 2003, Stephen Howell, unmarried and Bobby Murphy, unmarried woman, executed that certain mortgage on real property hereinafter described to First Franklin Financial Corp., subsidiary of National City Bank of Indiana, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20031211000800160, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A. as Trustee under Pooling and Servicing Agreement dated as of March 1, 2004 First Franklin Mortgage Loan Trust 2004-FFH1 Asset Backed Certificates Series 2004-FFH1, and

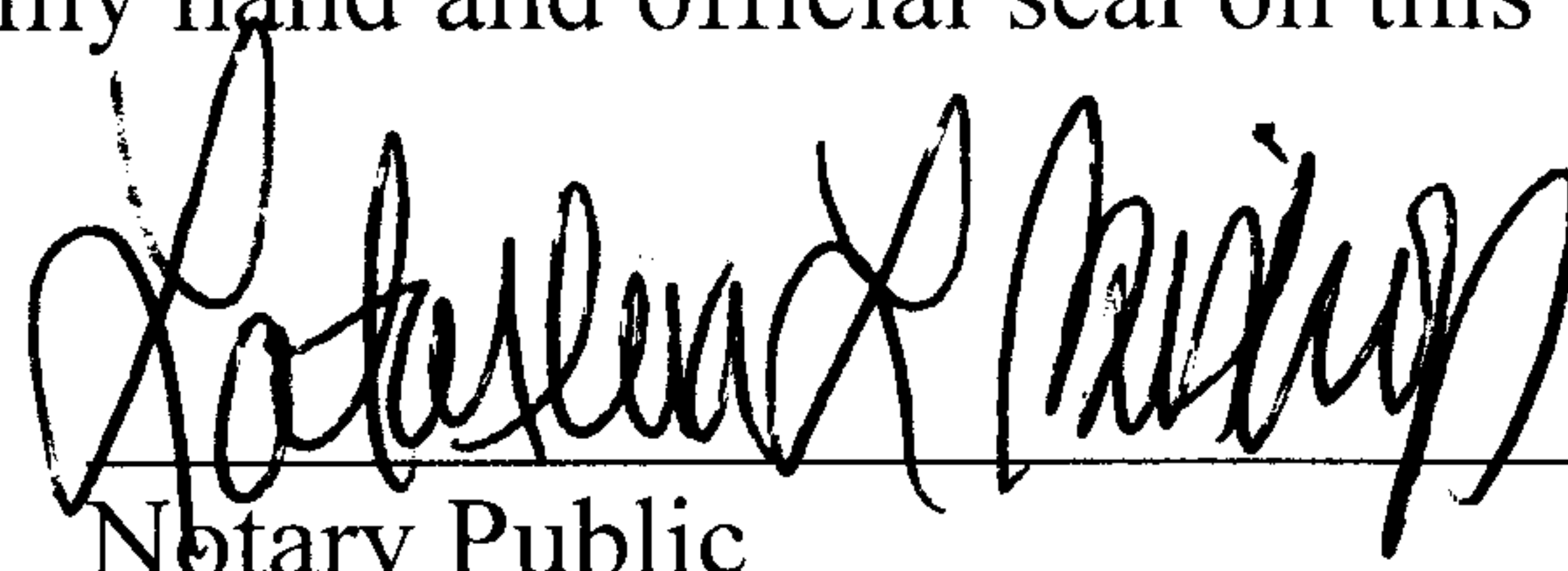
