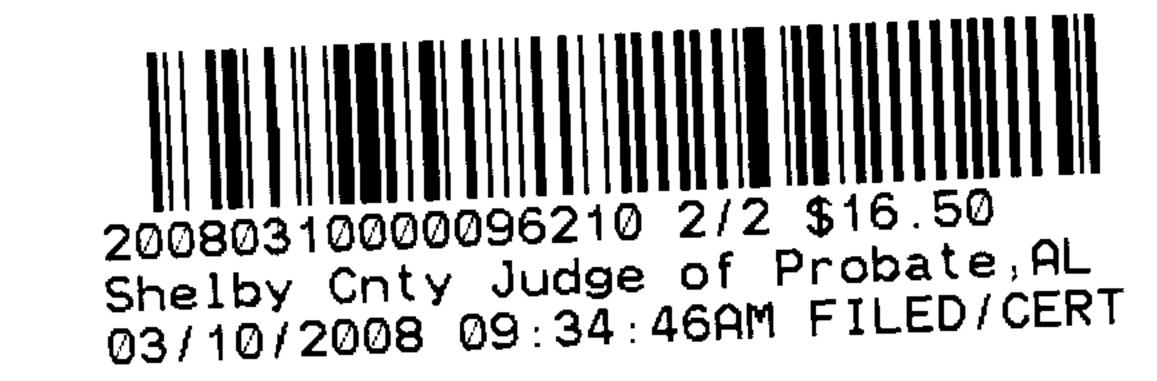


Exhibit A, Legal Description

Parcel One
