TO ALL PERSONS, be it known that I, the undersigned Evelyn Clara Majors, am making a Durable Power of Attorney with all powers thereof as follows:




2. AND FURTHER THAT:

KNOW ALL PERSONS BY THESE PRESENTS, which are intended to constitute a Durable Power of Attorney, that I, Evelyn Clara Majors, of 725 Highway 270, Maylene, (Shelby County,) State of Alabama, the undersigned, DO HEREBY MAKE, CONSTITUTE AND APPOINT my beloved granddaughter, Melanie Majors Hanson, of 145 Wooden Road, Alabaster, (Shelby County,) State of Alabama, my true and lawful Attorney in Fact, for me and in my name, place and stead, and on my behalf and strictly for my use and benefit, to do, perform and execute all and every act that I may legally do through an attorney in fact, and every proper power necessary to carry out the purposes for which this power is granted, with full power of substitution and revocation, hereby ratifying and affirming that which the said Melanie Majors Hanson or her substitute shall lawfully do or cause to be done by herself or her substitute lawfully designated by virtue of the power hereby conferred upon her. If for any reason Melanie Majors Hanson is unable to serve or ceases to serve as my Attorney in Fact, I then appoint my beloved daughter, Julane Glass, as my Successor Attorney in Fact.

The rights, powers and authority of my said Attorney in Fact (meaning my Attorney in Fact or my Successor Attorney in Fact) herein granted shall commence upon the execution of this instrument and shall be in full force and effect upon the execution of this instrument; the authority herein conferred shall not be affected by disability, incompetency, or incapacity of the said principal, **Evelyn Clara Majors**, and such right, powers and authority shall remain in full force and effect until the death of the principal, **Evelyn Clara Majors**, or until her disability, incompetency, or incapacity is otherwise terminated by order of a court of competent jurisdiction. Any action taken in good faith pursuant to the foregoing authority without actual knowledge of my death shall be binding upon me, my heirs, assigns, and personal representatives.
