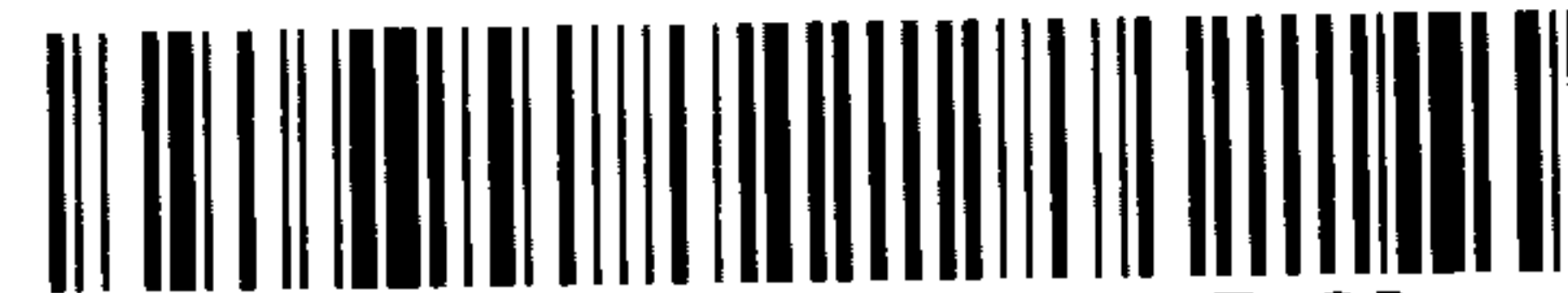
2, **AND FURTHER THAT:**

KNOW ALL PERSONS BY THESE PRESENTS, which are intended to constitute a Durable Power of Attorney, that I, **Evelyn Clara Majors**, of 725 Highway 270, Maylene, (Shelby County,) State of Alabama, the undersigned, **DO HEREBY MAKE, CONSTITUTE AND APPOINT** my beloved granddaughter, **Melanie Majors Hanson**, of 145 Wooden Road, Alabaster, (Shelby County,) State of Alabama, my true and lawful Attorney in Fact, for me and in my name, place and stead, and on my behalf and strictly for my use and benefit, to do, perform and execute all and every act that I may legally do through an attorney in fact, and every proper power necessary to carry out the purposes for which this power is granted, with full power of substitution and revocation, hereby ratifying and affirming that which the said **Melanie Majors Hanson** or her substitute shall lawfully do or cause to be done by herself or her substitute lawfully designated by virtue of the power hereby conferred upon her. If for any reason **Melanie Majors Hanson** is unable to serve or ceases to serve as my Attorney in Fact, I then appoint my beloved daughter, **Julane Glass**, as my Successor Attorney in Fact.
