#### ITEM THREE



Representative shall not be required to give bond or to file an inventory or appraisal of my estate though they shall make out and keep an inventory and shall exhibit the same to any party in interest at any reasonable time, and I direct that they shall be free from the control and supervision of any court.

- (B) I hereby vest in my Personal Representative and successor Personal Representative full powers of management, control and disposition of my estate, including the power to sell any or all of the property in my estate at public or private sale without the supervision of any court. The authority to sell real property without court or other heirs or beneficiaries approval extends fully to any and all real property I owned at the time of my demise including my homestead.


