EXPRESS NOTICE OF WAIVER OF TORT TO ALL WHO TRESPASS

Trespass upon the Issuer of the binding Private Bond Instrument, by any actor, agent or representative of a government entity or its subdivisions, acting under color of law outside the accepted forum, shall constitute an express agreement of \$2,000,000.00 compensation for each injury, occurrence of breach, or trespass on rights or property. Additionally, all who Trespass shall agree to pay \$65,217.00 compensation per each hour of compelled involuntary servitude, or coerced detention, or coerced booking, or coerced incarceration. Performance by conduct is acceptance. This is an implied contract and attaches only upon those who Trespass, and by their conduct elect to enjoin this contract. 
