The Resolution was seconded and unanimously passed by Richard Crisco, Randy Felschau, Lewis Nall, and Kyle Jernigan.

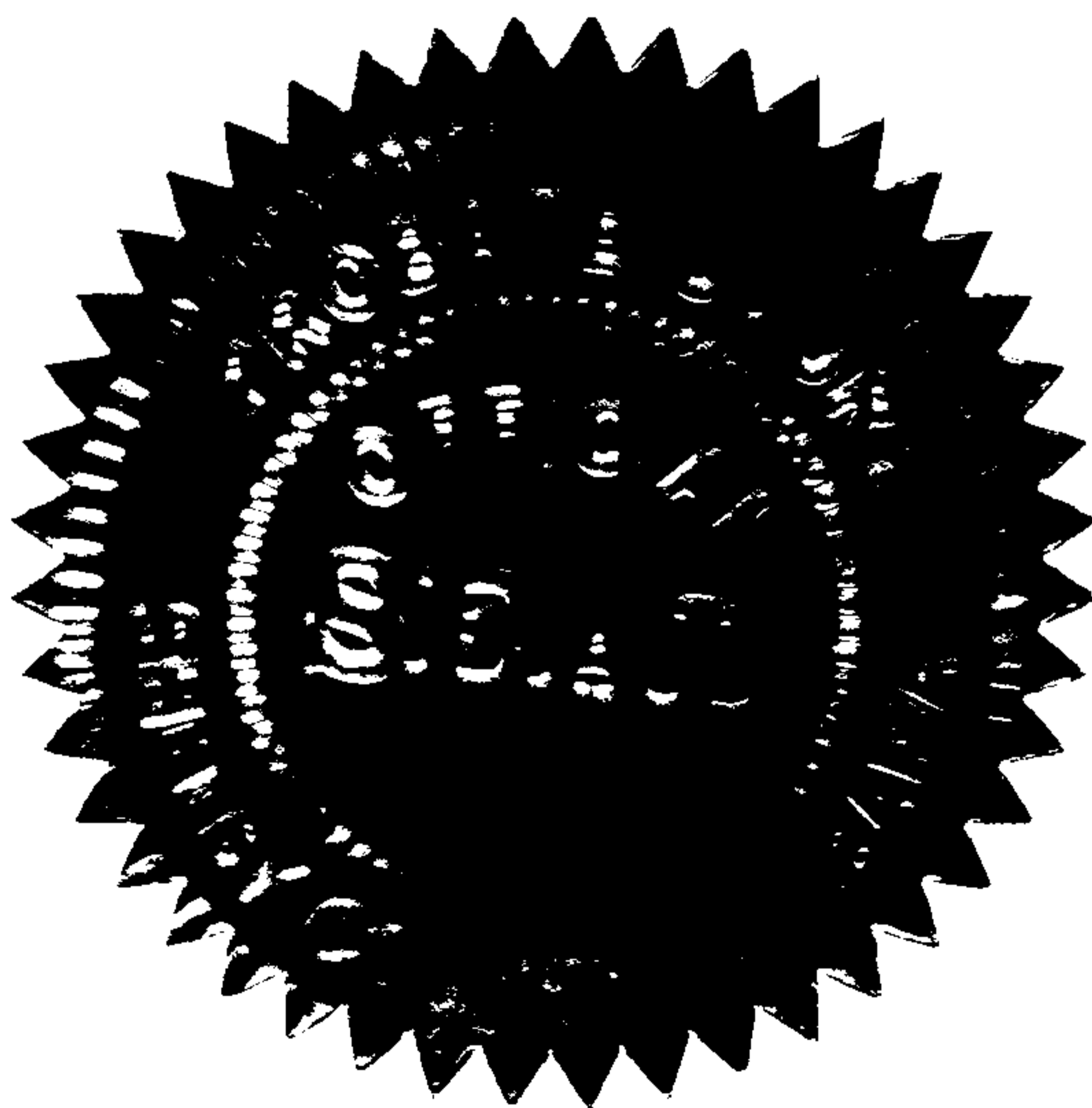
