WHEREAS, heretofore on March 26, 2002, **Brenda Staten, unmarried woman A/K/A/ Brenda Hamilton, a single person, Party of the First Part**, executed a certain mortgage to **HomeSouth Mortgage Services, Inc.**, which said mortgage is recorded in Instrument No. 2002-16078, in the Office of the Judge of Probate of Shelby County, Alabama.
