INSTRUCTIONS

STEP 1: WITHIN 30 DAYS OF A NAME CHANGE, FALSE OR ERRONEOUS STATEMENT IN THE ARTICLES OF ORGANIZATION, CHANGE IN THE PERIOD OF DURATION, OR A CHANGE IN ANY STATEMENT IN THE ARTICLES OF ORGANIZATION, AN AMENDMENT SHOULD BE FILED TO REFLECT THE OCCURRENCE OF THE EVENT(S).

STEP 2: FILE THE ORIGINAL AND TWO COPIES IN THE COUNTY WHERE THE ORIGINAL ARTICLES OF ORGANIZATION ARE FILED. THE SECRETARY OF STATE'S FILING FEE IS \$0. PLEASE CONTACT THE JUDGE OF PROBATE TO VERIFY THE PROBATE FILING FEE.

PURSUANT TO 10-12-11 OF THE ALABAMA LIMITED LIABILITY COMPANY ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF AMENDMENT:

Article I The name of the limited liability company:
Blessed Be the Name, LLC

Article II The date of filing of the articles of organization: 2/28/08

Article III The following amendment was adopted in the manner provided for by the Alabama Limited Liability Act:

Amendment to Article I
Added LLC to Blessed Be the Name

Article IV The amendment, consistent with the Limited Liability Company Act, was approved by a majority vote of the members entitled to vote or in accordance with the requirements set forth in the articles of organization and prescribed by law.

ARTICLES OF ORGANIZATION

OF

BLESSED BE THE NAME L.L.C.

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the probate judge of the county in which the initial registered office of the limited liability company will be located and affirm that the facts stated in the Articles of Organization are true and correct.

ARTICLE I

NAME OF COMPANY: The name of the limited liability company is
BLESSED BE THE NAME, LLC

ARTICLE II

DURATION: The period of duration of Blessed Be the Name shall be from the date of filing of these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama until the first to occur of the following:

- (1) Fifty (50) years from the date of filing of these Articles of Organization; or
- (2) Dissolution of the Company pursuant to the provisions of the laws of the State of Alabama or the Operating Agreement of Blessed Be the Name, as in effect from time to time.

ARTICLE III

PURPOSES: The purpose for which Blessed be the Name is organized is to manufacture and resell custom children's clothing. Additionally, Blessed Be the Name may enter into any business area or endeavor authorized under the laws of the State of Alabama.

ARITCLE IV

REGISTERED OFFICE AND AGEND FOR SERVICE OF PROCESS: The location and mailing address of the initial registered office of Blessed Be the Name shall be 213 Ledge Circle, Birmingham, AL 35242. The name of the initial registered agent for service of process at the foregoing address shall be Ashley Hutto Eiler.

ARTICLE V

INITIAL MEMBERS: The names and mailing addresses of the initial members of Blessed Be the Name are as follows:

ARTICLE VI

ADDITIONAL MEMBERS: Additional members may be admitted but only upon the unanimous written consent of the then existing members, as further provided in the Blessed Be the Name's Operating Agreement, as in effect from time to time.

ARTICLE VII

CONTINUITY OF BUSINESS: Upon the death, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in Blessed Be the Name, the business of Blessed Be the Name shall not be continued and the Blessed Be the Name shall be dissolved unless there is obtained the written consent of all the remaining members of Blessed Be the Name within ninety (90) days after the occurrence of the terminating event.

ARTICLE VIII

MANAGEMENT: Blessed Be the Name shall be managed by a manager or managers. The name and mailing address of the managers are as follows:

NO LIABILITY: The members of Blessed Be the Name shall have no liability for any debt, obligation, or other liability of the Blessed Be the Name, as provided in the Alabama Limited Liability Company Act.

ARTICLE X

PRINCIPAL PLACE OF BUSINESS: The principal place of business in the State of Alabama for Blessed Be the Name is 213 Ledge Circle Birmingham, AL 35242.


ARTICLE XI


