Know All Men by These Presents: That in consideration of **Two hundred fifty nine thousand nine hundred and no/100 (\$259,900.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Longleaf Homes, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Jami L. Noe and Brett E. Noe** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

\$246,905.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

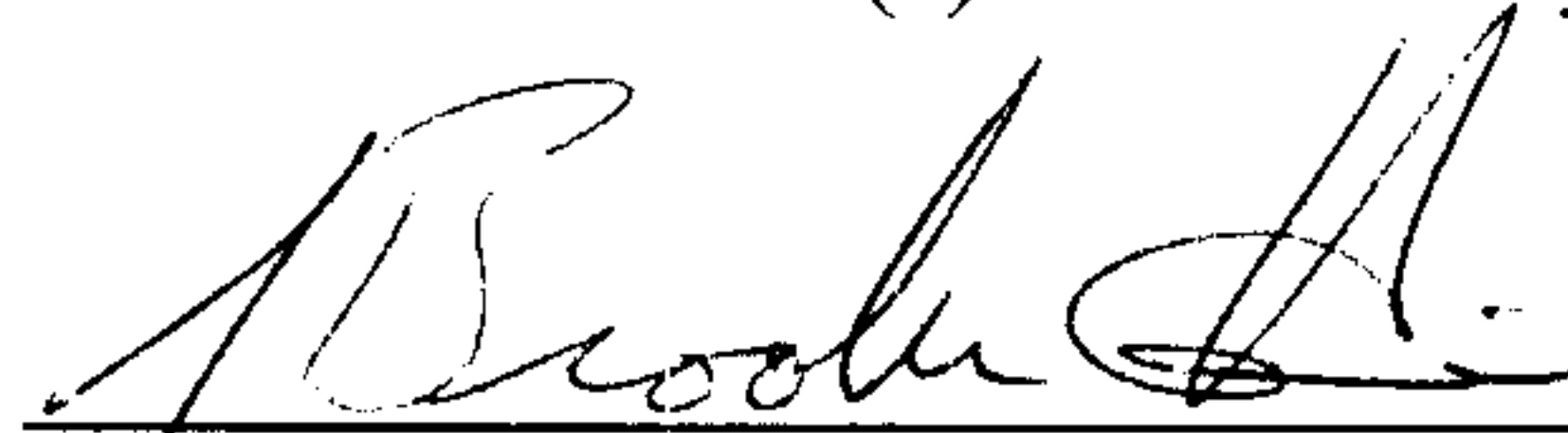

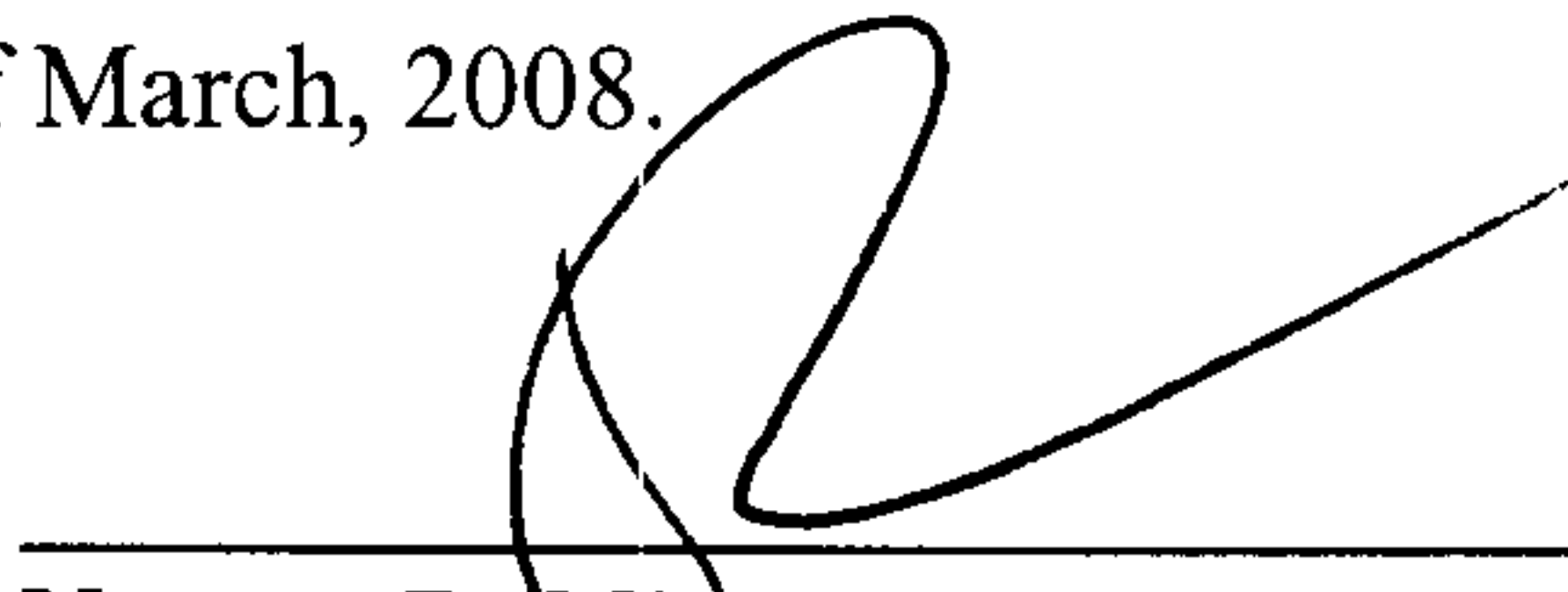
