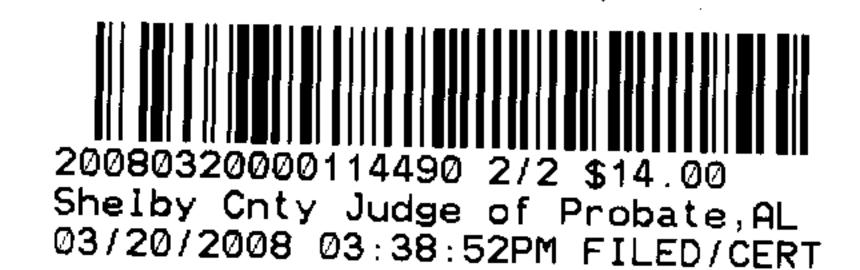

## **EXHIBIT A**

The NW 1/4 of the SW 1/4 of Section 12, Township 22 South, Range 2 West, Shelby County, Alabama.

## Together with:

Easement #1: Commence at the Southwest corner of the SE ¼ of the SW ¼, Section 12, Township 22 South, Range 2 West, and run East 146 feet, more or less, to the West right of way line of Alabama Highway 25; thence run in a Northeasterly direction along said right of way line 300 feet to a point of beginning; thence run in a Northwesterly direction 374 feet, more or less, to a point on the West line of said ¼ - ¼ Section which point is 441 feet North of said Southwest corner of ¼ - ¼ Section; thence turn North and run 879 feet, more or less, to the Northwest corner of said ¼ - ¼ Section; thence turn East and run 30 feet along the North line of said ¼ - ¼ Section; thence turn South and run parallel to the afore described line back to a point on the Northwest side of Alabama Highway 25; thence turn Southwest and run 30 feet along the Northwest right of way line of Alabama Highway 25 to the point of beginning. Said easement is situated in the SE ¼ of SW ¼, Section 12, Township 22 South, Range 2 West, Shelby County, Alabama.

Easement #2: A 60-foot right of way in the SW corner of the NE 14 of the SW ¼ of Section 12, Township 22 South, Range 2West, Shelby County, Alabama, said right of way being more particularly described as follows: As a point of beginning, commence at the SW corner of said NE ¼ of the SW 1/4 and run North along the West boundary of said forty to a point, which is 60.00 feet as measured perpendicular to the South boundary and a projection thereof of the NW ¼ of the SW ¼; thence run Southeasterly and long a curve having a radius of 50 feet with said radius point being the SW corner of said NE ¼ of the SW ¼, to a point on the South boundary of said NE ¼ of the SW ¼; thence run in a Westerly direction and along the South boundary of said forty for a distance of 60 feet, more or less, to the point of beginning.
