Subordination Agreement

THIS AGREEMENT is made and entered into on this 26 day of February 2008, by Regions Bank (hereinafter referred to as "Regions") in favor of REGIONS BANK, its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions loaned to MICHAEL G. CONNOLLY, JR AND SUSAN P. WILKENS (the "Borrower") whether one or more) the sum of \$358,000.00. Such loan is evidenced by a note dated 05/19/2000, executed by Borrower in favor of Regions, which note is secured by a mortgage, deed of trust, security deed, to secure debt, or other security agreement recorded 08/11/2000, in Record Book INST #2000-27469, at Page N/A, amended in Record Book N/A at Page N/A in the public records of SHELBY COUNTY ALABAMA (the "Regions Mortgage").
