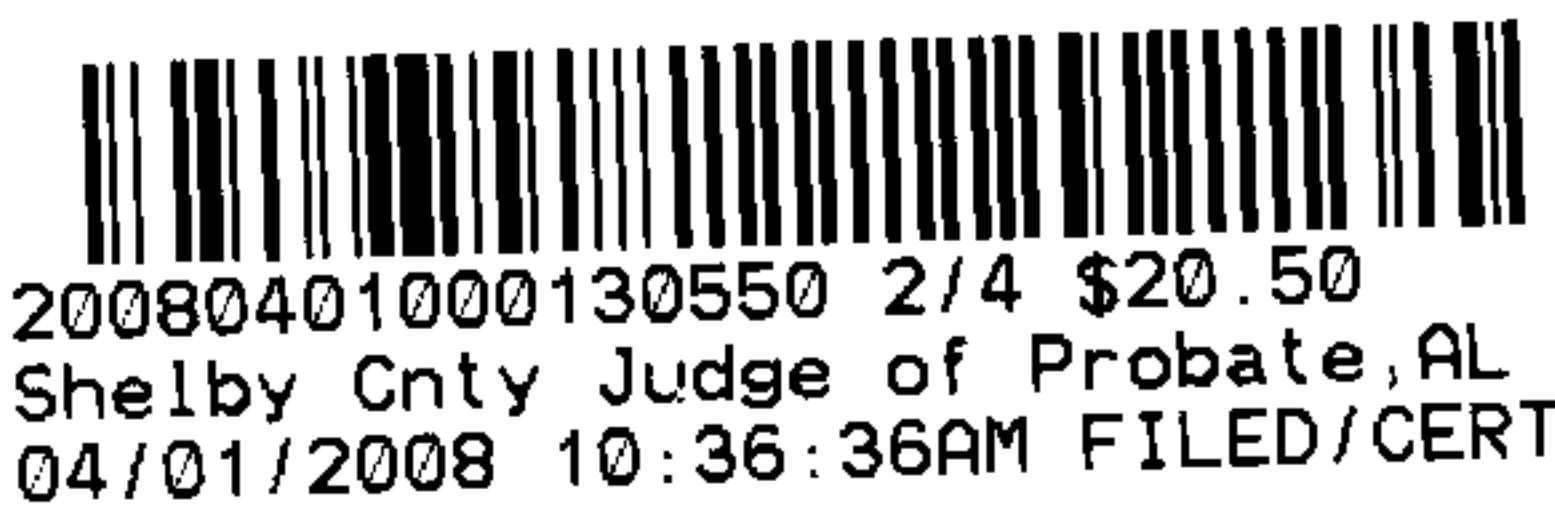

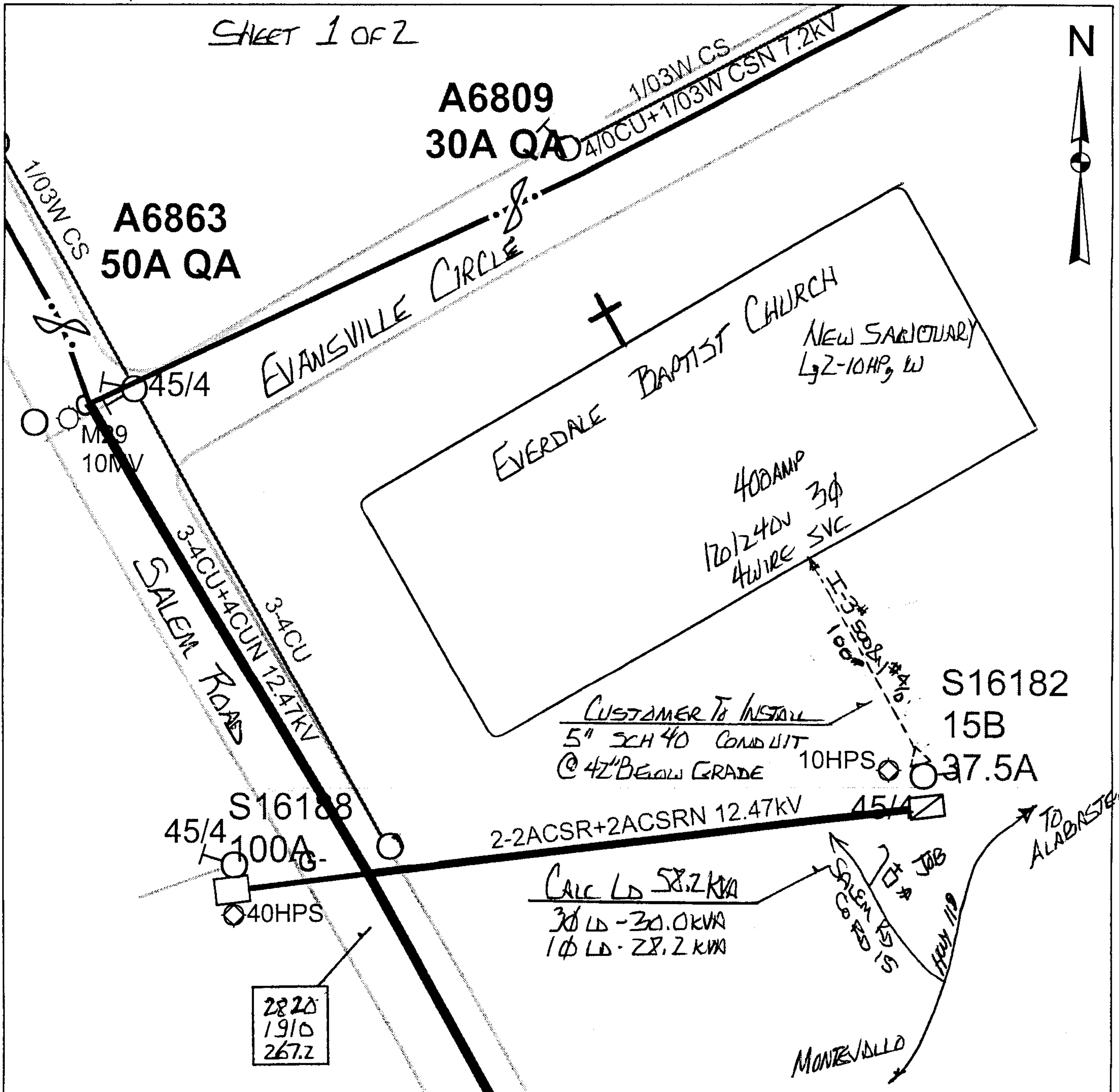
SKETCH OF PROPOSED WORK
