
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of November, 2005, Tanya Hiers, a married woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems Inc. as nominee for Aegis Wholesale Corporation., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument 20051201000622380, said mortgage having subsequently been transferred and assigned to Indymac Bank, F.S.B., and
