ORDER

THIS CAUSE coming on to be heard on Plaintiff Jenkins Brick Company's Application, Affidavit, and Entry of Default Judgment, and the Defendants, S & B Construction, LLC and Joseph A. Stamba, Jr. having been served on November 25, 2007, but failing to appear or otherwise defend this action, upon the affidavit of the Plaintiff and for good cause being shown, it is therefore ORDERED, ADJUDGED, AND DECREED by the Court as follows:

1. That a money judgment is hereby entered in favor of the Plaintiff, Jenkins Brick Company, and against the Defendants, S & B Construction, LLC and Joseph A. Stamba, Jr., in the amount of \$39,266.02, which said judgment is composed of \$30,710.89 in principal, \$2,412.95 in interest, and \$6,142.18 in attorney's fees, which are recoverable pursuant to the Contract entered into between Defendants S & B Construction, LLC and Joseph A. Stamba, Jr. and Plaintiff Jenkins Brick Company.

2. That a lien is hereby affixed and established as of May 1, 2007, the first date work or materials were supplied to the real property set forth below, in the amount of \$17,073.22 on

all the right, title and interest of the Defendant S & B Construction, LLC in the following described real property:

**Lot 2A, according to a Resurvey of Lots 1 and 2, The View at Indian Crest, as recorded in Map Book 38, Page 87, in the Probate Office of Shelby County, Alabama.**

3. Furthermore, the Court hereby orders that the above-described real property be condemned and sold in satisfaction of the aforesaid Lien herein established.

4. That a lien is hereby affixed and established as of July 23, 2007, the first date work or materials were supplied to the real property set forth below, in the amount of \$13,637.67 on all the right, title and interest of the Defendant S & B Construction, LLC in the following described real property:

**Lot 15, according to the survey of View at Indian Crest, as recorded in Map Book 37, Page 48, in the Probate Office of Shelby County, Alabama.**

5. Furthermore, the Court hereby orders that the above-described real property be condemned and sold in satisfaction of the aforesaid Lien herein established.

6. Costs are hereby taxed against the Defendants S & B Construction, LLC and Joseph A. Stamba, Jr. for which let execution issue.
