WHEREAS, heretofore on February 28, 2005, **Tracy Ross Ball, Unmarried, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc. a separate corporation acting solely as a nominee for Homequest Capital Funding, its successors and assigns**, which said mortgage is recorded in Instrument No. 20050316000118940, in the Office of the Judge of Probate of Shelby County, Alabama, , Party of the Second Part; and
